Again, this comment is made by someone who is not in the shot at the time it was said and I am not able to identify who made the comment.

4. In KENCOV1007 V2017042500021, at 00:08:45, please identify the name of the staff member (identified as Staffer 4) who said "No, no, no. It's here."

This member of staff is not in the shot when this is said and I am not able to identify who this is.

In KENCOV1012 V2017050400021, at 00:21:34, you ask a staff member (identified as Staffer
 whether the wing is getting locked up and they said no. Please identify the name of this staff member.

This member of staff is not in the shot when this is said and I am not able to identify who this this is.

- 10. In KENCOV1012 V2017050400021, from 00:21:36-00:22:00, please identify as many staff, both speaking and not speaking, as you can, and if you can, please identify what they say and the number they are given in the subtitles (e.g., "Staffer 6, Staffer 9").
  - Between 00:21:36 and 00:21:41, you can see two members of staff walking left to right along the balcony – then the officer in navy turns and walks out of shot to the left. This is DCO Clayton Fraser. The other officer in a white shirt who continues to walk to the right to the centre of the building and then holds onto the rail and looks out over the netting is DCM Shane Farrell.
  - At 00:21:52:00, an officer with a beard and glasses briefly appears at the left hand side of the frame. I believe this officer went by the name of GG, though I do not know his real name. I believe he was usually posted at Tinsley House (G4Ss other Gatwick IRC).
  - At 00:21:56:00, a DCM wearing white shirt comes into shot. The sub-titles identify him as 'Staffer 6' and he says 'GG, here'. His name is Ben though I do not know his second name.
  - At 00:22:00, the subtitles say that Staffer 9 says 'Lock up'. I do not know the name of 'Staffer 9'.
  - At 00:22:01 the subtitles say that Staffer 6 (DCM Ben) says 'lock up yeah, lock up'. This is inaccurate. I believe this was said by GG.
- 11. In KENCOV1012 V2017050400021, at 00:24:29, please give (if you can) the officer "Sunil's" surname.

I do not know Sunil's second name.

- 12. In KENCOV1012 V2017050400022, at 00:03:39 and following, please identify the names of the individuals who appear to be staff members who say the following: (shown as Unknown) "Please man [inaudible]", (shown as Unknown) "Let's get him banged up" and (identified as Staffer 1) "You two [inaudible]".
  - I believe the 'Unknown' person who said 'please man' was a detainee. I do not know his
  - The voice of the person who says 'Let's get him banged up' sounds like Ryan Bromley, but I cannot be sure it was him who said this. My attention at the time was on D1527.
  - The person identified in the subtitles as Staffer 1 who says "You two,[ inaudible]" is DCM Steve Dix. He actually says "You two, bang up [inaudible]. He is talking to Sunil and I.
- 13. In KENCOV1012 V2017050400022, at 00:05:33, please identify the name of the staff member (identified as Staffer 2) who says, "we're not letting people in [inaudible]."
  - This was a new member of staff whose name I do not know. You can make out a small part of his face if you freeze the frame at the aforementioned time code and look at the bottom left of the frame.

- 14. In KENCOV1012 V2017050400022 clip 2, at 00:19:59, please identify the name of the staff member who said (identified as Staffer 4) "Stuart's taking [inaudible]"
  - I do not know the name of this officer. I think they are talking about Stuart Povey-Meier.
- 15. In KENCOV1012 V2017050400022 clip 2, at 00:20:50 and following, there is a gathering of officers and managers. Two of the individuals present are Clayton Fraser and Steve Dix.

  Please identify the others' names, including which officer in the video corresponds to which name, and by reference to their location in the footage and the relevant timestamp.
  - At 00:20:40, on the right hand side of the screen is the DCM named Ben, who I refer to in my answer to question 10. He was present for the conversation, though he does not always appear in the footage.
  - At 00:20:56, Clayton Fraser is standing to the left out of the shot. The are four people in shot. On the left of screen is an officer called Mark. I do not know his second name. Looking at the screen, to the right of Mark is a Tinsley House DCM whose name I do not know. Further to the right is another DCO whose name I do not know, but he is the same member of staff referred to in question 7. To the far right of the screen there is DCM in a white shirt with his back towards the camera, who is Ben.
- 16. In KENCOV1012 V2017050400022 clip 2, at 00:24:06, please identify the name of the staff member (identified as Staffer 15) who asks if D1527 is okay?
  - I do not know the name of this member of staff. I believe she may be a nurse.
- 17. In KENCOV1012 V2017050400022 clip 2, at 00:24:17, please identify the name of the staff member (identified as Staffer 16) who says, "[inaudible] not happy"?
  - I do not know the name of this member of staff. In fact, I do not even recognise him. He may have been one of the new DCOs, or perhaps he was a DCO from Tinsley House IRC.
- 18. In KENCOV1016 V2017051300011, please identify which staff member is which in the footage (by reference to Officer 1, Officer 2 etc, and Nurse 1, as well as their images in the video).

Please note, that in the table below I refer to a member of the Senior Management Team as Dan Haughton. My recollection was that Dan's surname was Laughton or Lawton. The Inquiry has, however, identified the officer as Dan Haughton and, as I did not normally use officer's surnames, I am happy to accept the Inquiry is likely correct.

  - I do not know the names of the nurses in the room.
  - In this clip, various members of staff were in the room, including Nathan Ring, a male officer
    wearing glasses whose name I do not know and Hayley. I am unable to say exactly when
    each officer came into or left the room.
  - At 00:17:40 when the nurse and I are talking about if a detainee will die soon, there was no one else in the room at this point, besides the detainee.
     At 00:21:33, the sub-titles read 'Callum Tulley Getting a lot of this, ain't we'. This is incorrect as it is not my voice. I do not know whose voice this is.
  - At 00:25:28:11 I do know the name of the male officer who says 'Is that Taylor Swift?' . I believe that DCM Hayley entered the cell at around this point.
  - At 00:26:39:20 the 'Unknown' member of staff who says 'Alright? X factor next year, yeah?' is DCM Hayley. She is stood to my right when this is said. I believe that DCM Nathan Ring re-entered the cell at around this point.
  - At 00:26:52:00, an officer wearing glasses who has been sat to my left gets up, goes to D1275 and then returns to his seat. I do not know the name of this officer.
  - At 00:27:21:21 DCM Hayley is the unknown member of staff talking about orange juice.
  - Nathan Ring is the 'Unknown' member of staff talking at 00:28:28:15, at 00:28:34:24, and at 00:28:37:13. He is shown later in the clip at 00:29:04:22
  - DCM Hayley is shown at 00:28:57:14
- 31. In KENCOV1035 V2017061400016 at 00:00:20, what is "Hayley's" surname?

I do not know Hayley's second name.

- 32. In KENCOV1035 V2017061400016, please identify the staff members (including nursing staff) who are in the room with D1275, and by reference to their location in the footage and the relevant timestamp?
  - I do not know the name of the nurse present.
  - At the very start of this clip DCM Nathan Ring and DCM Hayley are both in shot at 00:00:00:20.
  - There is a mistake in the subtitles at 00:01:19. Nathan Ring does not say '[inaudible] he looks alright'. It is the DCO officer in glasses, whose name I do not remember, who says this.
  - At 00:03:16, a big, bald DCM appears. His name is Nick London.
