STATEMENT	<b>OF TRUTH</b>	BY D1234	Ì

I make this statement of truth as per events that happened to me on the 28th of March 2017 at Brook House IRC.

On this day, eight officers came into my cell and 2 of them held my head and turned it violently in their attempt to turn me around. I felt a crack in my neck and I informed them, but they took no notice. They pushed me and I hit my head on the floor. Then I was grabbed and jostled.

Another one of them held my throat and one of them stamped on my toes violently. I felt as if life was coming out of me, I was in extreme pain and I asked them to stop. They refused and ignored me.

I was handcuffed on both wrists with the cuffs biting into my wrists again I screamed that I was in pain but I was ignored. I was grabbed on the legs and my legs were pushed upwards from the feet. I again screamed because my knees were extremely painful.

Both of my legs were tied and my stomach lump which was to be operated on had a strap put on it in order to strap me up.

I was in extreme pain, I was screaming and asking for help. I was ignored and completely helpless and dehumanised, I thought I was going to die.

I was carried out of the cell completely naked, I was stripped of all dignity, humanity and sense of self. I was in extreme pain and asking them to stop but was ignored. I have injuries all over my body

I was thrown into a security van and driven to Stanstead Airport naked. I was brought back to Brook House in a wheelchair and thrown into a cell and locked up. The cell was so cold that I was shivering. There was no

heating. I was extremely terrified, I thought I was going to die.

I kept screaming that I was in pain but I was denied access to see a doctor, I was only allowed to see a nurse on the day, there are bruises on my wrist, stomach and several parts of my body. I was told that I should go and treat myself when I get to Nigeria.

I am an innocent man and not a criminal and yet I have been subjected to the most extreme form of violence and dehumanisation. My humanity, dignity and sense of self was stripped off.

I am still having pains and flashbacks, I cant sleep, anytime I hear the jingle of keys or the steps of officers I feel scared and unwell. I cannot work properly as I drag one of my legs. I have pains and aches all over my body.
