Bullying:

'Conduct motivated by a desire to hurt, threaten or frighten someone. It can be physical, verbal, psychological, emotional or economical and often very subtle. It is usually repeated behaviour, unprovoked and intended to cause fear or harm to the victim.' Bullying cannot be mutual: it always involves a power imbalance. This distinguishes bullying from fights and assaults'.

ANTI-BULLYING MANAGEMENT PROCEDURES

D1275

Gatwick IRC will support and protect all detainees who are victims of bullying.

The investigating Wing Manager meet with the individual to discuss the victim's feelings about the bullying and what they want staff to do to support or protect them. All victims will be given the opportunity to attend Personal Development sessions facilitated by the Safer Community Manager.

However, the level of support and guidance provided will depend for the most part on what the detainee finds helpful and comfortable. It is essential that the wishes of the victim should be considered at all stages.

CASE REVIEWS:

Case Reviews must be held on a weekly basis to ensure the individual is adequately supported. However, if the wing manager feels it is necessary then reviews can be scheduled more frequently.

A document must be open for at least 14 days before it can be closed. This is to allow sufficient time for the individual to be supported and monitored.

Case Review meetings should be **conducted by the Wing Manager** in the individual's presence. They may be attended by any person who can provide information on his progress such as:

- Wing Officer
- Education/Workshop/Religious Affairs
- Safer Community Team

REFUSAL TO ENGAGE:

If at any point a detainee refuses to engage, refer him to the Safer Community Team Leader/Safer Community Manager. If this continues a Case Conference will be arranged to determine how to proceed.
