one that is going to authorise for this guy to be forcibly removed, because it might go all
wrong and then what? Where you getting it from?
Male Manager 1: So okay, let me ask you a question.
D87 Yeah.
Male Manager 1: Fair enough. Now obviously, yes, you're being detained.
D87 Yes.
Male Manager 1: We come here hopefully, all our job is for you to go to a temporary.
You don't have to [inaudible] so they come back [inaudible].
DB7 : Yeah. I've - this is a - bruv you know, okay, look, listen to this, listen to
this. This, the last time they come to get me was a clear cut, clear cut clear opportunity,
5 a.m. in the morning. So 5 a.m. in the morning was even a better time when they could
have taken me by force but the guy that I spoke to, he had a camera. And they had a
[inaudible].
Male Manager 1: [Inaudible].
Male Manager 1: So D87 , listen, this is what's going to happen. If you're happy to
walk down with me and Shane, stick to the escorts, right? Because at the end of the day
[inaudible] our job is for - is to present you to the escorts, right. This is where you
[inaudible]. If they then say they're not going to take you because of - and you've
indicated your reasons, this, this, then they note it down. That's it. Okay? That's
end of story. But our job here as DCN, DCOs, whatever you want to call us, officers,
screws, whatever, is for you to be presented. Okay? So if you're saying you're not going
to go to the Verne then what I'd like you to do is come down to the centre, speak to the
escorts. Cos they're the ones [inaudible].
I know how this thing works. You're going to take me to the reception.
Alright. You're going to end up coming to pack up my stuff to forcibly get me there,
whether I comply or not.
Male Manager 1: No, I'm not -
D87 : Do you understand what I mean? So obviously you're not using force,
you're using your mind. Your mind is understandable but what I'm saying, the last time I
was asked the same thing, can I come to the reception, I said, look, I don't want to go
there and then [inaudible]. You know what I mean? It's such a small world you don't
know [inaudible].
Male Manager 1: At the end of the day right?
D87 Yeah.
Male Manager 1: [Inaudible].

D87 Yeah, I know [inaudible].
Male Manager 1: Simple task [inaudible]. So we've got a reason to say that
D87 Yeah.
Male Manager 1: So like I said to you, our job, D87, transport to the escort. And
you go down there and you mitigate to them your reasons. It will be documented for us
and be documented for them. They then say, okay, we're still going to take him or we're
not, and that's [inaudible] okay? So we're not using force on you because [inaudible].
That's what I'm saying, you can't use force on me.
Male Manager 1: So it's nothing, if you're saying that we can't then why don't you
come down and speak to [inaudible]?
D87 Yeah I know but what I'm saying, I understand, I know, but what I
mean -
Male Manager 1: [Inaudible] come on.
Yeah, yeah, I know but what I'm saying is -
Male Manager 1: We're going down to the reception.
D87 : No, come, come, this is not about - no, what I'm saying is, I don't want
to get to the reception and you're gonna have to come and pack my things. D'you
understand I've got an important document here and all the rest of it? What I'm saying,
I don't wanna be fooled, innit.
·
Male Manager 1: Okay.
D87 : D'you understand what I'm saying to you? I'm already upset to leave
the [inaudible] I was in agony. Do you understand? So I like straight forward innit? Yeah,
I like straight forward. So -
Male Manager 1: So how about -
D87 If you think -
Male Manager 1: How about -
If you think that we're going to the reception and nothing ain't gonna
change because they say I'm going to the [inaudible] -
Male Manager 1: I don't know.
D87 : Tell me that.
Male Manager 1: I don't know what they're going to say.
So I know, innit. But -
Male Manager 1: Just calm, calm.
Male Manager 1: D87 calm down.
D87 Yes, go on.
Male Manager 1: How about, cos I don't know what they're going to say [inaudible]
well
D87 Yeah.
Speaker 1: How about, whilst me and Shane here, pack your stuff in bags, right.
D87 : Yeah.
Speaker 1: Put your stuff in bags. [Inaudible] we can say you had your bags packed,
right? You packed your bags yourself. If we then go down there and they say
[inaudible], we are taking you, then your bags will come pack as you had packed. How
about we do that? Because then, listen, you're still talking to Tascor, who's the escort,
you're still doing you're mitigation, if they say they're still going to take you, you've
already packed your bags and you know where shit is. And -
Shane Farrell: We're saying, you know you've got documents.
Male Manager 1: How about, that's a half-way meet, man. How about we do that?
B87 : Yeah but I might as well just sit, okay, comply with you and go to the
[inaudible] if you're telling me because you [inaudible].
Male Manager 1: [Inaudible].
D87 No, no, what you're saying to me is but at the end of the day, this is not
my home, I want to go home. Two bases, either Africa or release here where I've been
living for 25 years. This [inaudible]. So there's nothing that would like, you say, oh
compliance, all of that, doesn't threaten me or it doesn't make me scared.
Male Manager 1: Yeah that's for you [inaudible].

Doesn't change my mind. You know when someone does so much bad to
you, you become immune to it yeah? So I'm saying, I've been punished so much here
I'm immune to it. Yeah?
Male Manager 1: Yeah?
D87 Like someone held me in detention for 12 months in jail, can you
imagine how you feel? As someone that is a citizen of this country?
Male Manager 1: [Inaudible].
D87 Anywhere in the world is [inaudible] that. Do you understand?
Male Manager 1: Yeah.
Alright, I'm on [inaudible], three months later I'm [inaudible]. That's
what I mean. And now I'm getting all this drama, oh if you wanna get moved to
somewhere three hours away, all of that. I'm saying no. I'm saying it don't make no
sense.
Male Manager 1: But like -
D87 I've told Home Office that and then I'm hearing all this tone that is
really not the tone I want to be hearing -
Male Manager 1: No, it's not -
D87 Cos I'm telling my man the only reason I think you can use force on me
is if I were to be removed from this country. Not to go to another detention centre. Do
you understand what I'm saying? Cos I know what I'm saying I've got the book there I can show you. You should not be using force to take me from one detention to another
detention. That's a show. Do you know what I mean?
Male Manager 1: Lets go to [inaudible].
D87 So I'll tell them I'm not going away.
Male Manager 1: Okay. So you need to speak to [inaudible] about it.
Yeah, what I'm going to tell em? I'm not going and then I come back.
Male Manager 1: Okay.
Yeah, I'm not going. You alright with that?
Male Manager 1: If they're not taking you, they're not taking you. Come on.
D87 Well I'm saying I can't go nowhere, innit?
Callum Tulley: Just cut it. Well done mate.
Male Officer 1: D'you want me to come down with you?
D87 [Inaudible] what are they called? Sutton Mews? Yeah. The people in
charge of movement, yeah?
Callum Tulley: [Inaudible] stages.
Male Officer 1: Good.
Male Manager 1: But at the end of the day [inaudible] that's when they'll decide. Cos
[inaudible]-
D87 [Inaudible].
Male Manager 1: [Inaudible]. End of story. End of day. You understand?
Unknown Speaker: [Inaudible].

ī	DPA _45 minutes away and it would be difficult for me to go somewhere I've never
i.	been before to try come and visit to drive that far to come and see me. I know family will
	do anything for you but it's not fair on them to be putting this burden on top, I'm being
	detained, they don't even know what's going on [inaudible], she's only six. Yeah, she's
	crying every time she comes in. Yeah. So she, I don't know, I can't - am I telling her
	[inaudible]. What am I telling her? It's like all of this is no good. See what I'm saying to
	you? And you can understand the emotion that goes with that. When you try and explain
	it to someone and they're not with you, what happens to me? I explode. Now, I'm
	warning you first right, like I said. Yeah? I'm saying why did you call me to show
	something that you don't know this guy who you think is a cool guy is going [inaudible].
	Do you know what I mean? So, cos you're my guy, I'm talking to you like that, innit,
	that I could just walk quiet and then just - boom - why did you do that? [Inaudible]. Do
	you know what I'm saying to you? Because of how I'm feeling like I'm being compressed
	too much.

i	Do you see what I'm saying to you?
	Male Manager 1: Yeah. I bet you
	I'm saying if that would happen, and I'm talking to you on a one to one,
	why can't you avoid it? So you [inaudible]? I'm getting [inaudible]. If somebody's making
	me ill, why you gonna travel me? If someone is not mentally alright, depressed and all
	that, why you wanna travel them? Do you know what I mean?
	Male Manager 1: Yeah.
	D87 That's how I feel now. I feel like I'm getting mentally disturbed. Like I'm
	getting a depression [inaudible] on my own today, that all of that is still be together,
	yeah, it's too much. And that because I can talk about it. You have to make me and
	shake my hand and say you know where I'm sticking it. We can do this another time and
	not today. D'you see what I'm saying to you?
	Male Manager 1: Yeah, but this is why -
	D87 Because -
	Male Manager 1: This is why we're talking to you [inaudible]. That's what I'm saying
	to you.

	with me [inaudible] okay. So that's basically for me, for me I need to get you to a level
	so you can [inaudible]. So that is [inaudible] and that's doing the same thing to the
	escort. So if you explain to them your reasons for wanting to stay here [inaudible].
	D87 Who's doing first time round?

Male Manager 1: Is that the escorts?
D87 : Is that them is it? [Inaudible].
Male Officer 2: [Inaudible].
[Inaudible] locked up in [inaudible].
Male Manager 1: When you say [inaudible].
It's not that, yeah. It's not that. Do you think you'll take me anyway?
[Inaudible] If I'm - in fact if I [inaudible] immigration because of me alone, I wanna leave this country. I'd have been gone a long time. I would've signed and said,
[inaudible].
Male Manager 1: [Inaudible].
Male Manager 1: If you didn't have a family, you wouldn't be doing fuck all.
That's what I'm saying. [Inaudible].
Male Officer 2: It's not them.
D87 You see what I'm saying? It's [inaudible] not to
be all put apart or whatever [inaudible] -
Callum Tulley: [Inaudible] I could have sworn they were here.
D87 - here for myself, I come here [inaudible].
Callum Tulley: I could have sworn they were here.
D87 Look, if you know what I said to him, do you know what I said to him?
Male Officer 2: [Inaudible]
Callum Tulley: Ah.
D87 : D'you understand what I'm saying to you?
D87 Yeah.
D87 Yeah. D87 Because there's not any other reason why I [inaudible] is, when you
reason with somebody, then you work with reason. You reason with me [inaudible], I
respected you. I'm here, the escort [inaudible].
Male Manager 1: But you -
D87 My time is really stopping here. I need to carry on with my life. Eat the
food, whatever, pack my stuff, even if it comes to that. Speak to the family, tell them
what's going on. But - I don't want to be in here, like in here [inaudible]. You
understand?
Male Manager 1: Let me -
Male Manager 1: [Inaudible].
D87 Please.

Unknown Speaker 1: Well yeah.

Unknown Speaker 2: I deal with it all the time.

Unknown Speaker 3: [Inaudible].

Male Escort Staff 1: Don't worry about it. Obviously [inaudible].

Male Manager 1: Is that the best one there is? [Inaudible] Anything else?

Male Manager 1: He's had [inaudible]. He's had [inaudible].

Callum Tulley: Hmm, he is. Unknown Speaker 4: Yeah.

Male Manager 1: I've been trying to talk to him [inaudible].

Callum Tulley: Yeah, we were trying to negotiate with him for a good hour now.

Male Manager 1: An hour, an hour now.

Male Manager 1: [Inaudible] Put him back then.
Male Manager 1: He's not going to comply neither.

Male Manager 1: He's left his stuff upstairs [inaudible].
Male Escort Staff 1: Well, it's the one he normally takes.

Unknown Speaker 4: If that is all out, why is it all [inaudible]?

Male Manager 1: He said it was - he said it was probably the family [inaudible].

Callum Tulley: That's true.

Male Manager 1: He'll make life hell.

Unknown Speaker 4: Innit?
Male Manager 1: [Inaudible].
Unknown Speaker 4: [Inaudible].

Male Escort Staff 1: We're not allowed to. Male Manager 1: No, well [inaudible].

Callum Tulley: Have you got a choice of whether you take him or not?

Male Escort Staff 1: Not really.

Male Manager 1: [Inaudible] down to me.

Male Escort Staff 1: What - what could happen possibly, if you - you could possibly

ring out control to say look [inaudible].

Male Manager 1: That's - that's for you to do

Male Escort Staff 1: Yeah.

Male Manager 1: That goes on to your own risk assessment

Male Escort Staff 1: Yeah, but risk -

Male Manager 1: I mean, give my [inaudible].

Male Manager 1: But you need to do it your way. Cos you're happy when you're allowed to take him [inaudible]. Cos if he does come out, then that's when you - and he does kick off, everything else, that's for you to risk assess.

Male Escort Staff 1: Yeah.

Male Manager 1: I've told you what I've spoken to him about. They've got me [inaudible] for him to remove [inaudible].

Male Escort Staff 1: Yeah, yeah, I understand. No, I appreciate that.

Male Escort Staff 1: Who's she on the phone to?

Female Escort Staff 2: Paula.

Male Escort Staff 1: By the sound of it, it needs four men.

Female Escort Staff 2: Probably. Be easier, wouldn't it. If he's a big fella, common sense tells you. I mean, cos the only one, cos it's a cell vehicle it's not as if we can belt him up. We've got a -

Male Manager 1: He'll smash the fuck out of it.

Female Escort Staff 2: Yeah. Exactly. Well, brilliant. For \mathcal{E} an hour. I look forward to that. [Inaudible] anyway, wouldn't he, me and her.

Male Manager 1: You got family and kids?

Female Escort Staff 2: Yeah. He's going to fight me, isn't he.

Male Manager 1: Callum?

Female Escort Staff 2: At least you're being honest.

Male Manager 1: He's got family and that that he said he doesn't [inaudible] and do whatever

Female Escort Staff 2: Nah. Or he'll just go down the [inaudible] won't it?

Male Manager 1: Put it in [inaudible].

Female Escort Staff 2: The only thing we've got really is [inaudible].

Male Manager 1: This is what I'm saying. When I need to get him through, because he's out there getting up like this.

Female Escort Staff 2: Yeah.

Callum Tulley: Let's get the team kitted then. Earlier, I said to Ben like, why don't [inaudible] -

Female Escort Staff 2: I mean before when I've been -

Callum Tulley: He was saying to me, trust me, you don't need to have big [inaudible] on it. [inaudible]

Female Escort Staff 2: Yeah.

Callum Tulley: You don't just need blokes, need big blokes.

Female Escort Staff 2: Big blokes.

Male Manager 1: [Inaudible] they'll have to be. That's why you [inaudible].

Callum Tulley: That's true. Unknown Speaker 2: Bye.

Unknown Speaker 3: Take care, take care.

Callum Tulley: Well I know it was D87 I was like, fuck that, you know what I'm

saying?

Male Manager 1: So when I go -

Male Escort Staff 1: Yeah.

Male Manager 1: - I'll get him out, you can [inaudible] to me then you've got - Male Escort Staff 1: Well, we'll see what - we'll see what they're sorting out. They might turn round and say, right, we'll bring some bigger blokes up and basically.

Male Manager 1: We'll have to get a move on cos he's in there and he's going to start [inaudible].

Male Escort Staff 1: [Inaudible].

Male Manager 1: Yeah but what I'm saying to you, I'm saying to you, cos he's in there, he's getting pissed off, once he goes in to the [inaudible], if you want to take him, that's what we can do is nip up, talk to the wing and go forward that way. Cos he's on the understanding that he's come down to mitigate to you and this is where you decide to take him, which is your call. That's it. Obviously he's been there waiting ages to get more and more pissed off -

Male Escort Staff 1: Yeah, yeah, yeah.

Male Manager 1: - that's where we're starting saying, right, we need to know what's happening with you. Get him out and talk to you. Cos if you ain't taking him, so we can bin him back up.

Male Escort Staff 1: Yeah.
Male Manager 1: [Inaudible].

Female Escort Staff 2: In a normal van it's [inaudible].

Female Escort Staff 2: Right, okay.
Unknown Speaker 2: [Inaudible].
Callum Tulley: Have you seen him yet?

[Male Escort Staff 1 shakes head]

Female Escort Staff 2: Yeah. I've - I've [inaudible] queue but I'll phone back in a minute.

Shane Farrell: Shove up.

Male Manager 1: Alright. Okay, bye.

Female Escort Staff 2: We need to talk to him anyway.

Male Manager 1: Shane?

[Male Manager 1 and Shane Farrell leave room]

Male Escort Staff 1: How tall is he?

Female Escort Staff 2: We need to talk to him. And then, I mean, if he's fucking [inaudible] size of units they say he is, £ is not enough per hour to get my arse

kicked by some bloke who don't wanna go. He does realise he can come back, doesn't he? Unless you don't want him back. Female Officer 1: We don't tell him that. Male Manager 2: Yeah, he won't be. He's very against the system and thinks that [inaudible]. Male Manager 2: Yeah, that's basically what it is. **Female Escort Staff 2:** Yeah, so he's not gonna leave soon. He's [inaudible] twice then. It's a lot of trouble. Female Escort Staff 2: Has he been like that the whole time he's been here then? Male Officer 1: Absolute [inaudible]. Female Escort Staff 1: Oh yeah? p87 enters room with Male Manager 1 and Shane Farrell] Female Escort Staff 2: Good morning sir. Or afternoon -D87 : Good evening. Female Escort Staff 2: - I think. D87 : Yes. Male Manager 1: [Inaudible] talking about the reasons why you don't want to go D87 : First of all cos my family live round the corner. My children [inaudible] so obviously number one [inaudible]. They live 45 minutes away from here so I've informed the Home Office about it three weeks ago. I don't know why they've made [inaudible]. I've spoke to you about three weeks ago. Male Manager 1: About three weeks ago, yeah yeah. D87 : And the same with the Home Office and I demonstrated to them that I can't go far because of my family is literally 45 minutes away from London. **Female Escort Staff 2:** Which makes sense and we get that. D87 And so any other thing -Female Escort Staff 2: It has been explained to you, though, hasn't it, that once you go, you - the thing is, because this is a London-based one near Gatwick, when there's charter flights going out of here -D87 Yeah. Female Escort Staff 2: They move all the people that are not on flights out so they can move all the people in -It's because they're saying I'm not a single occupant. So it's nothing to do with charter flight or not, that thing. Also this week I've got a bail application that is going in, which is going to be held in [inaudible]. So I don't, you know, I'm stressing up. I've got headache, I've got, what do you call that? High blood pressure, all that stuff going on right now. I don't really - I'm not fit to travel, do you understand? The simplest way to put it, like I was trying to explain to that officer there, so I'm not even trying to be funny or what. Female Escort Staff 2: It's just we have - we have to talk to you and we have to tell you that because we're a suitable crew -D87 : Yeah. Female Escort Staff 2: - we can force you to go there by using force. D87 Okay. Female Escort Staff 2: You can -You explain -Female Escort Staff 2: Yeah. No, no, no. I get that, they do their job, they tell you everything. You can also ask to be transferred back because of your family being round D87 ; Okay. Female Escort Staff 2: But the only thing I want you to understand is that they do use all these centres near London to fill up for charter flights and I'm not saying that that's acceptable for you, cos your family are here, but there is flights going out so they empty

them, put everyone who's not on flights somewhere else and then those people can ask

to come back. And that does happen. Normally with quite quick turnaround.

D87 But I still don't understand what -

Female Escort Staff 2: I just need to - I have to tell you that.
D87 : Oh yeah, I understand you like you inform me and I spoke to him last
time to do with this as well. Like I said, I'll be refusing but cos he explained, he said
come and talk to you and explain obviously what the situation is and how that - like
seriously, I can't even travel today. I've got a serious bad headache and [inaudible]. The
nurse now cos I've been stressing on the phone to the family and the rest of it, taking it
out of [inaudible]. It's just not gonna work, seriously. And it's not me refusing, cos I'm
obviously [inaudible] use force. It's not like I'm afraid neither but it's not - that's not the
best way for you to sort out issues sometimes, is it? So that's why I've come to comply
and talk to you sensibly. So, you know.
Female Escort Staff 2: Response to that is because we're a suitable crew -
D87 : Right.
Female Escort Staff 2: - we - we could tell you that we have to take you anyway.
D87 : No, I understand.
Female Escort Staff 2: D'you know what I mean? So -
D87 You say you can tell me -
Female Escort Staff 2: Yeah.
D87 : - but I'm telling you reasons I can't travel. First of all cos I'm not fit to
travel, I don't feel well right now.
Female Escort Staff 2: Have you seen -
headache and it's on my record that I've got blood - high blood pressure.
Female Escort Staff 2: Yeah.
D87 : And that's not a good sign.
Female Escort Staff 2: No, no, no, I - I get all that.
D87: So if you're gonna take me on a long journey for three and a half hours

D87 No, but he knows why I'm chatting to him like that, you know.
Van Paschali: But what can be do?

Callum Tulley: I'm an activities officer. Do you realise that?
No fucking running. This guy's calm with all of us here and we just try t
fuck him around like. I'm not - I'm cool with everyone. D'you know what I mean? Why
do you try and fuck me around?
Yan Paschali: At the time - at that time, he will know -
D87: If I was being a prick, right, he could just say, oh, you're a prick. You
know what I'm saying?
Derek Murphy: Yeah, yeah, yeah.
D87 1: He would be how I'd deal with you.
Derek Murphy: Put your fucking hands up and
D87 I haven't done anything wrong. Yeah? And I'm saying, I'm here to do
my little detention till I get out and legally I know how to fight my case, I'm fighting it.
To get out the right way, you know? You understand? Now and then I run jokes with you
but I've not fucked you around for you to say, oh this guy, fuck him or whatever. It's
not - I don't deal with people like that.
Yan Paschali: We were totally expecting you not to be rude, but to be back on your
wing. Has anyone come down? Normally the managers are all over the fucking place.
Have they come down?
No, nothing. Because they can't pinpoint nothing. You know where I'm
coming from but - I've had [inaudible].
Callum Tulley: Yeah, I know where you're coming from actually. It's not my fault.
1've not given no one no aggro. I've not even said fuck off to him. Not
even that. You understand? I've not even - have I said that to you?
Callum Tulley: No.
D87 : Exactly. So what's happened? You [inaudible].
Callum Tulley: But I've had nothing to do with it D87 I've had nothing to
do with it. You do realise that? I've had nothing - I was just there.
D87 k No. You know why [inaudible].
Callum Tulley: I've nothing to do with the decision-making process.
You were there. You were there. He was there, big man.
Yan Paschali: D87 -
D87: Don't let him try run away that he was not there. He was there.
Yan Paschali: You can bear witness cos [inaudible].
You should've called him [inaudible].
Callum Tulley: Yeah, I was there.
: And he ain't done nothing. Because the deal, the man cut a deal -
Callum Tulley: Yeah, I was there when they made the deal, I didn't make the deal. I
was there when it was made.
D87 - He shook my hand. He goes, oh, he's a Tascor, that's it. Bottom line,
you're going back to your wing.
Yan Paschali: Yeah.
D87 You know what I mean?
Yan Paschali: You know what - you know what to say to them tomorrow? If I was you.
D87 : How can I say that, man? How can I say that?
Yan Paschali: How can I deal with you ever again?
D87 I would never.
Yan Paschali: Because if they say, oh [inaudible], we'll just walk over here [inaudible].
You know what I said to him as well? I said this world is so small, yeah,
you might be treating me like this, you don't know where we're going to buck up
tomorrow. It's not even a threat. You might just meet me somewhere tomorrow but it's
just the way he's treated me is gonna make him feel uncomfortable. Cos you thought I
was gonna be here for ever but look at me here now with you.
Yan Paschali: [Inaudible].
D87 I know.
Yan Paschali: You ask for [inaudible]. I'd say, yeah, I'd sort him, [inaudible]. But I
might say, I'm not sure if I can do it.
D87

Yan Paschali: But I'll try. You don't say I've got it sorted -D87 : I'm gonna fuck off. Yan Paschali: - and then [inaudible]. D87 Yeah. You're the big man. Yan Paschali: [Inaudible]. D87 And you wear shirts, you know. One of them gave me that, goes don't worry, you're allowed to go everywhere. Tall fella with a thing. He didn't come back. The other guy came, oh yeah, you okay? You can go. All of them is docked up. This is cowardice. You can't behave like that. Be a man. Yan Paschali: We're gonna be on your side. That's what I'm saying. <u>D87</u>: Yeah but seriously it's not fair because, you know, like me, I'm just being, you know, like [inaudible]. Yan Paschali: I'm not one of them [inaudible]. Male Officer 1: Callum? Callum Tulley: Yeah? Male Officer 1: [Inaudible]. Callum Tulley: I'll take 'em. I'm gonna take 'em up. Leave it shut.

Callum Tulley: Right.

Male Officer 1: Take them up.

Male Officer 1: Are you taking - you taking the big guy and all the others?

Callum Tulley: D87 D612 doesn't want to. Bipolar guy -

Male Officer 1: Yeah.
Callum Tulley: - and -

Male Officer 1: That was having a bit of a [inaudible].

Callum Tulley: And the black guy in room 3.

Male Officer 1: If you don't do anything for 'em straight away in terms of cell

[inaudible] -

Yan Paschali: It's like he's infatuated with me.

Male Officer 1: Yeah.

Yan Paschali: You just want to fucking [inaudible].

Male Officer 1: I know.

Yan Paschali: I can't handle [inaudible].

Male Officer 1: You've seen that - when you said, give it a rest mate, like that, didn't

you, he sat out there, the old bottom lip.

Yan Paschali: When I walked out [inaudible]. He was fucking serious. 'Remember

Burn?' So I said, we'll have a game of chess. It was a newbie [inaudible].

Male Officer 1: Yeah, he was, wasn't he. Cos I - I was sitting - I was down the other

end. I said to him, you alright? He went...

Yan Paschali: Fucking hell! Male Officer 1: [Inaudible].

Yan Paschali: Mate, this is the honest truth. He said, 'my heart is hurting. I miss my Mummy and my Daddy'. And I was just like, mate, fucking grow up, will you. You're a man.

Male Officer 1: He's been so institutionalised down here, ain't he. What's he been down here now? Two, three months?

Callum Tulley: Why's he been [inaudible]. He was on association before?

Yan Paschali: I don't know.

Male Officer 1: The issue's so far back I can't remember, but... Yan Paschali: We're not overly friendly so I don't fucking get it.

Male Officer 1: No, it's - it's cos you occupy him. You deal with the chess and everything else like that. So he appreciates that, so that's why he latches on to you more than anybody else, innit? It's just like...

Yan Paschali: I can't play chess with you all day. He would follow me to the toilets.

Male Officer 1: Oh yeah, he would do, yeah.

Yan Paschali: I went one day, I went down there. He went, 'where are you going?' I say, 'I'm going for a fucking piss.' And one of the detainees says, 'do you want to hold it for him?' Honestly!

[Phone rings]

Yan Paschali: It's not [inaudible] is it? Fuck's sake.

Unknown Speaker 1: Hello?

[End of conversation]

Derek Murphy: I said to him, mate, 'you're doing my fucking head in, mate. You give me a fucking headache listening to you.'

Yan Paschali: [Inaudible].

Derek Murphy: He just wants you to fucking be available, you know.

Callum Tulley: Who? [Inaudible].

Derek Murphy: She said to me, are you afraid of him? Do you remember him saying

that?

Callum Tulley: I wouldn't fancy having a fight with him though, I've got to say.

Yan Paschali: It's fair enough, you [inaudible].

Callum Tulley: Well, we - with you lot in here I'd be alright, wouldn't I? But -

Yan Paschali: - weigh. I'd love to get in the ring with him. Put the gloves on and see what he's fucking made of. I would love to. He's got shoulders. His chest is titty. He's got

a gut. His arms ain't all that. He's just got some shoulders and a bit of height. Fucking crack him straight in the ribs.

Derek Murphy: Straight in the solar.

Yan Paschali: Yeah. There's nothing here at all.

Derek Murphy: No. I'd hose him. And I'd draw it - when I was away to a friend's pub one night, it was an open night, [inaudible] Road. I was there as a guest. Got any

fucking [inaudible] or that. I think I told you this, this geezer -

Yan Paschali: [Inaudible]. Yeah you did tell me. Did you drop the cunt? Derek Murphy: Yeah. Well, his feet were fast and he done my nose -

Yan Paschali: Yeah. That's how he ruined your shirt.

Derek Murphy: [Inaudible] bang! Right between, right there. He was - that was it.

Callum Tulley: Who was that?

Derek Murphy: So I said to him, fucking did him, I tell you.

Callum Tulley: Who was that?

Derek Murphy: I don't know who he was. Some fucking idiot. Thought he was fucking

Bruce Lee.

Yan Paschali: That happened to me once as well. I think I told you this story before. My sister had a bit of a car collision somewhere and they were trying to mug her off, so she phoned me. I shooted off down there. She'd touched his car from behind, so he was walking round the car going, yeah, there's a dent there. At the front. You know like, [inaudible]. I said to him, says to the guy, [inaudible], I get in the car, fuck off. So I noticed he left his keys in his engine and my sister had given him her mobile number for insurance and all that shit, and she'd put it on the front seat. So I'm like walk me round the car mate, yeah, yeah, no, there's damage there. And I'm thinking, he must think I'm a mug. She'd tapped him from behind a little bit, he's showing me the archways, the fucking front panel, side panel, the [inaudible].

Derek Murphy: [Inaudible] I remember you telling me, yeah.

Yan Paschali: So anyway, I opened the door and took the piece of paper with my sister's mobile number on, put it in the fucking pocket and shut the door and I went, 'you must think I'm a fucking mug, mate.' So I come round to him and he's gone, 'what?' I said, 'you fucking heard, you prick. Showing a damaged front. I'm going to fucking smash your face in.' He jugged me straight in the face. Just went, 'ping'. I've gone, 'you cunt'. Fucking split my lip. And then he went, 'ooh', turned around and ran. Fucking ran up the road after him, this is in broad daylight, kicked him to the floor, and fucking boxing and boxing him, kicking him, punching shit out of him. My mate was in the car with the missis. He's [inaudible] -

Derek Murphy: Eh, eh, eh! What you doing? **Unknown Speaker:** I will bring the tea towel back.

Derek Murphy: No.

Unknown Speaker: I'm just there.

Derek Murphy: Fucking just - what do you think this is? **Yan Paschali:** Why don't you just go the kitchen next door?

Derek Murphy: No! [End of conversation]

Yan Paschali: Right, anyway. Well, my missis come round and jumped in the car. Drive, drive, drive! She was going. I'm covered in claret, mate. My fucking hands. I had white trainers on. [Inaudible]. Got home, took all my kit off. It's like I committed a murder. I didn't, but binned it all fucking... yeah.

Derek Murphy: [Inaudible]. Beat a man to death in [inaudible]. He admitted.

Yan Paschali: Did he? Callum Tulley: Aye.

Derek Murphy: So is that young fella -

Callum Tulley: Never had a death in custody here, have they?

Derek Murphy: Who? Where? **Callum Tulley:** Brook House.

Derek Murphy: Don't fucking say that yet. That's the wings there and it's not the same

as here, look.

Callum Tulley: Okay.

Derek Murphy: It's the wings in [inaudible]. Same as here. Not that clean. That's not

how we look. It is, you know, it's... A, B, C wing.

Callum Tulley: Probably our first photograph that was taken of it when it was just built. **Derek Murphy:** That's the induction wing there. See this, this is the induction wing.

It's - reception's out there and we're round here.

Yan Paschali: Is that the uniform?

Derek Murphy: Huh?

Yan Paschali: Is that the uniform you had?

Derek Murphy: Yeah, we had white shirts. We had all white shirts.

Yan Paschali: Looks like prison officers.

Callum Tulley: Yeah.

Yan Paschali: That's why all the guys think you're a screw as well.

Derek Murphy: Huh?

Yan Paschali: That's why the guys here think that you were a screw with us, because

the uniform's the same. **Derek Murphy:** Yeah?

Yan Paschali: What was the colour of your - did you wear epaulettes?

Derek Murphy: Just had them, didn't have nothing on them.

Yan Paschali: We had our number on them.

Derek Murphy: No, we didn't have nothing on them.

Yan Paschali: So if you was to - Callum Tulley: You had numbers?

Yan Paschali: Yeah, like -

Callum Tulley: Like ID numbers, like police officers?

Yan Paschali: Yeah, we had. We had a number. So if you wanted to put a complaint in against me, I'd be like, go on mate all day long. Mine was WW350. Now they want my name.

Callum Tulley: Thing is though, Yan, you're used to fighting people like **D87** Cause you was in prison. I fucking wasn't mate.

Yan Paschali: I never learned how to fight in prison. I only done 8 years in prison

service. I grew up in [inaudible]. **Callum Tulley:** MMA aren't you into?

Yan Paschali: No. See, see the stories, look see MMA.

Derek Murphy: What was that?

Yan Paschali: He said I was into MMA. Everyone's got a thing about MMA at the

moment.

Derek Murphy: See this is what I was saying to you.

Callum Tulley: [Inaudible] fucking putting people in sleep holds in [inaudible] - **Yan Paschali:** oh I forgot you witnessed that. Oh it was so funny Derek, I wrapped up this fella right, [inaudible].

Derek Murphy: I remember [Inaudible]. **Yan Paschali:** Getting upset [inaudible].

Callum Tulley: I weren't getting upset, I was blowing out my arse, you prick.

Yan Paschali: No but I'm choking him and he's going, I thought 10 more seconds you're going to sleep. He's like 'Yan Yan I think that's enough'. [Inaudible] do you know

what I've got this [mimics choking], don't worry about it'. [mimics choking]

Callum Tulley: I shat myself, I'm not gonna lie. The nurse was right behind you Yan, so.

Yan Paschali: That's why I didn't, Callum Tulley: [Inaudible].

Yan Paschali: Nah its good because obviously she's fucking...

Callum Tulley: Not going to lie [inaudible] but.

[Phone rings]

Yan Paschali: Hello - Yeah.

Callum Tulley: So easily avoidable as well.

Derek Murphy: What?

Callum Tulley: So easily avoidable as well.

Derek Murphy: Yeah. A load of this, well as [inaudible] was saying to [inaudible] I went

not wrong, I'd say. [Inaudible] to whatever will be same again.

Male Officer 1: You can sync the locks, so if we do need to get him out a no notice, you

can do it quite easily.

Yan Paschali: D'you [inaudible] on the wing or not?

Female speaker on television: What's your experience of [inaudible]? **Derek Murphy:** You were in every crew there, whatever, [inaudible].

Callum Tulley: The things is, is when I stood there and like he would've actually - I reckon he would've gone if they'd just basically said, you're coming whether you like it or not, like. Without force needing to be used. But she was saying - she was saying to him, like, the woman, she was like, look, you're a big guy, d'you understand that like if you don't go today, you're gonna have to go like in a few days anyway? They will come and get you. And he was like, yeah, yeah, I understand all that, I understand that. And she was like, we need to make - she was making such half-hearted attempts to actually persuade him to go. Like they just clearly didn't want to take him.

Male Officer 1: It wasn't a very suitable - suitable crew, was it?

Callum Tulley: It was two - it was two males and - of about medium build and then two very small females.

Male Officer 1: Well he could just fight them off in the car and just get out the car and go, can't he, really?

Yan Paschali: It's a cellular vehicle.

Male Officer 1: You what?

Yan Paschali: It's a cellular vehicle. Callum Tulley: Suitable crew. Male Officer 1: Oh, is it? Oh, okay

Yan Paschali: The minute you load him on, you lock the door. He's in a cell basically in the back of the van.

Male Officer 1: Yeah. In a prison van. Yan Paschali: Like a metal plate [inaudible].

Male Officer 1: Prison van. Fair play.

Male Officer 2: It wasn't a normal Tascor van, it was a prison van.

Yan Paschali: This is what I'm saying. We could've put him on the van if needs be. I've done it before.

Derek Murphy: [Inaudible]. We're not supposed to put them on the van I mean, I've put [inaudible] on the van, he'd lay down on the floor and [inaudible] I've done that lifts. Just chucked him into the cell.

Yan Paschali: [Inaudible].

Male Officer 1: Yes.

Yan Paschali: I go, fucking get in. Just fucking get in.

Derek Murphy: [Inaudible]. He said, [inaudible]. D'you want some air? I go, open the

door [inaudible] I ain't giving him a [inaudible].

Male Officer 1: That, what do you call it? [Inaudible] van then.

Derek Murphy: Yeah?

Male Officer 1: Second failed removal.

Male Officer 2: Second?

Derek Murphy: Is there a reason why you didn't equalise?

Callum Tulley: Who's D4038 Male Officer 2: Is that it?

Male Officer 1: And they sent him back because he cried.

Callum Tulley: Who's D4038

Male Officer 2: Just plays in the first one -

Male Officer 1: Very small. Afghan I think, Afghan?

Male Officer 2: Afghan.

Callum Tulley: Oh, is he the guy that was on the constant supervision just before his

flight?

Male Officer 1: Yeah, yeah.
Callum Tulley: He's a small bloke.
Derek Murphy: [Inaudible] away.

Male Officer 1: He cried and they sent him back.

Callum Tulley: What, from the flight? It's the second - second failed removal? **Yan Paschali:** That can't be right. That can't be. What, cos he cried? You don't

[inaudible].

Male Officer 1: Unless the pilot took them out.

Derek Murphy: Cos he was escorted this morning. I said, why - why d'you come back?

He said, he cried.

Male Officer 1: Fucking hell!

[End of conversation]

Yan Paschali: [Inaudible]. Cos I thought he'd start crying.

Male Officer 1: Who said that?

Yan Paschali: It's very difficult to explain. Callum's had a taste. He didn't cry but he

got a bit upset.

Callum Tulley: I didn't cry. I was tired Yan. I was fucking knackered. You didn't see me

having to try and pull him out of the toilet when he -

Yan Paschali: Callum, hear me out. When you saw him. I said, you didn't cry.

Callum Tulley: Yeah, I know. I know I didn't.

Yan Paschali: But you got a bit upset. I didn't say you cried. What I'm trying to explain

is the likes of us, if these guys see us in full action, they'd be delighted.

Callum Tulley: Try me, mate. **Male Officer 1:** I'd love to watch it.

Yan Paschali: We don't cringe at breaking bones. [Inaudible] bones.

Derek Murphy: No, that's [inaudible].

Yan Paschali: If I killed [inaudible] I wouldn't be bothered. I'd carry on. A lot of people are freaked out when you [inaudible]. Not you but [inaudible] but like proper bit scared.

[Inaudible]. Someone like that, fucking [inaudible].

Male Officer 1: Oh, fucking can't watch that.

Yan Paschali: Yeah.

Male Officer 1: [Inaudible] pain. I don't think I'd manage.

Yan Paschali: [Inaudible]. Callum Tulley: Nice girl.
