19 **Callum Tulley:** And how did Shane[?] and his son get pulled into it?
20 **"Ginge" Male Officer:** Same thing.
21 **Callum Tulley:** What, they were giving him stick as well?
22 **"Ginge" Male Officer:** Yeah, same thing.
23 **Callum Tulley:** The same incident?
24 **"Ginge" Male Officer:** Well, no, I think it's different days.
25 **Callum Tulley:** Right.
26 **"Ginge" Male Officer:** But, yeah.
27 **Callum Tulley:** What happened to the detainee?
28 **"Ginge" Male Officer:** He's still about, maybe, yeah.
29 **Callum Tulley:** Do you know what detainee it was?
30 **"Ginge" Male Officer:** It's that D119
31 **Callum Tulley:** Oh was it D119
32 **"Ginge" Male Officer:** Yeah.
33 **Callum Tulley:** Oh wow.
34 **"Ginge" Male Officer:** Yeah. So that's why –
35 **Callum Tulley:** I bet Babs is fuming that D119 sort of –
36 **"Ginge" Male Officer:** Well –
37 **Callum Tulley:** If that's true, that D119 given abuse –
38 **"Ginge" Male Officer:** Well, it is what it is. Well, he's been suspended –
39 **Callum Tulley:** – he's – he's reacted, and there have been no repercussions for D119 that's
40 what it sounds like to me.
41 **"Ginge" Male Officer:** Well, he's been suspended without – with pay.
42 **Callum Tulley:** Oh right.
43 **"Ginge" Male Officer:** So, they're literally paying for him to find a new job which is a plus.
44 **Callum Tulley:** He wants to leave, Babs, doesn't he, anyway.
45 **"Ginge" Male Officer:** Huh?
46 **Callum Tulley:** Babs wants to leave anyway, doesn't he?

47 **"Ginge" Male Officer:** Well, yeah, but he's at that age, isn't he?
48 **Callum Tulley:** That's what he told me. I suppose if his son's here, now, though, it might be
49 a – it might be umm – it might have been quite nice for him to stick around.
50 **"Ginge" Male Officer:** No, I think they want – both want to go back to High Down.
51 **Callum Tulley:** Really?
52 **"Ginge" Male Officer:** HMD, yeah, because they got like thirty-K jobs there.
53 **Callum Tulley:** oh right.
54 **"Ginge" Male Officer:** Yeah, that's...
55 **Callum Tulley:** Jeez, fair enough.
56 **"Ginge" Male Officer:** Be careful what you say, mate.
57 **Callum Tulley:** Eh?
58 **"Ginge" Male Officer:** Got to watch what you say.
59 **Callum Tulley:** Watch what you say, yeah.
60 **Joe Marshall:** Yeah, so true that, in the current climate.
61 **Joe Marshall:** [inaudible]
62 **Callum Tulley:** Do you reckon it was...?
63 **"Ginge" Male Officer:** Oh, no doubt.
64 **Callum Tulley:** Who do you reckon it was? Staff – do you reckon staff dobbed him in?
65 **Joe Marshall:** Dobbed who in? What are you talking about, Babs?
66 **Callum Tulley:** But surely – surely if the –
67 **"Ginge" Male Officer:** There's no doubt – no doubt – well, yeah – [inaudible]
68 **Callum Tulley:** Because I wouldn't think – sorry, mate.
69 **Joe Marshall:** Do you know anything yet, Ginge, come on.
70 **"Ginge" Male Officer:** I can't [inaudible]–
71 **Joe Marshall:** Are you talking about Babs?
72 **"Ginge" Male Officer:** I'm not –
73 **Callum Tulley:** Yeah. Because I would've thought if **D119** made a complaint, they wouldn't
74 suspend people just like off the bat like that.
75 **Male Officer 3:** **D119** the one who made the complaint.
76 **Callum Tulley:** Yeah, yeah, I know he made the complaint.
77 **"Ginge" Male Officer:** But then –
78 **Callum Tulley:** They won't just take a detainee's word for it –
79 **"Ginge" Male Officer:** No, he spoke – no, no, he spoke –
80 **Callum Tulley:** – to suspend someone, would they?
81 **Male Officer 3:** Yeah, that's true.
82 **"Ginge" Male Officer:** No, he put the complaint in –
83 **Callum Tulley:** Surely it's – do you know what I mean, Ginge?
84 **"Ginge" Male Officer:** No. What's happened, he's put the complaint in –
85 **Male Officer 3:** I don't know.
86 **"Ginge" Male Officer:** – and they've gone to officers to confirm whether it's true or not.
87 **Callum Tulley:** Oh right.
88 **"Ginge" Male Officer:** Because the officers are, you know, obviously –
89 **Joe Marshall:** Who [inaudible].
90 **"Ginge" Male Officer:** I don't know. I don't know who was in, mate. Babs doesn't know
91 anything either because –
92 **Joe Marshall:** Bullshit, Ginge.

93 **"Ginge" Male Officer:** Well, no, he hasn't been sent anything.
94 **Callum Tulley:** Just say, Ginge.
95 **"Ginge" Male Officer:** No, I – I don't – I honestly don't – if I did, I'd tell you, who the
96 fucking man is. All I know –
97 **Joe Marshall:** Someones just been radio'd.
98 **"Ginge" Male Officer:** No one likes a snitch.
99 **Joe Marshall:** Has one of you just been radioed?
100 **Callum Tulley:** No, it was outside the corridor.
101 **"Ginge" Male Officer:** Yeah.
102 **Joe Marshall:** You're fucking right there no one likes a snitch. You're fucking right, Ginge.
103 **"Ginge" Male Officer:** We get it from upstairs, we get it from them. We don't need to get it
104 from each other.
