As things stand I do not believe PSU should take this forward.

CID indicates there was an attempted removal on the date claimed, however the issues raised seem to be around the fact that a restraint belt was applied (allegedly too tightly), that the subject was laughed at when he broke wind, and that he was embarrassed at having to perform toilet functions in the presence of officers. These are around the circumstances of operational decisions while the alleged laughter is a behavioural allegation unlikely to constitute serious or gross misconduct. I would be content for this to be considered locally however if more compelling evidence is forthcoming we would be happy to reconsider.
