Officers were dispatched to check on their intentions and they reported back that a protest was taking place and they intended to stay on the courtyard and not return to their wings. The detainees were given the opportunity to return but they remained on the courtyard so the door was locked to enable a roll count to commence around the rest of the centre. Officers were deployed to maintain security in the sterile area in case detainees tried to breach the fence. The command suite was opened and announcements were made over the tannoy to see if any detainees wanted to surrender and return to the wings. A short time later a medical response was called for in the courtyard as [D2045] appeared to be having a seizure. Officers and Healthcare entered the courtyard to assist him but some of the detainees reacted with hostility which resulted in two members of staff being assaulted. Officers were told to retreat which they did taking [D2045] with them. The detainees were then ready to surrender and a controlled evacuation took place relocating detainees back to their rooms.
