Colleagues – I am writing in advance of a Panorama undercover film of 4 months in Brook House which will be aired on Monday night (4th September). Although the centre is not identified, the programme is already trailed on the BBC website. Although the Home Office will not be making any comment before the programme, we are planning against the risk of speculation emerging before the weekend.

G4S is still working through the detail, but we know there will be recording of a small number of DCOs expressing unacceptable attitudes towards detainees, and some, as yet uninvestigated, allegations of excessive use of force. There will be reporting of use of psychoactive substances, and familiar lines on length of detention and failure to remove foreign national prisoners quickly.

As we would expect of any of you, G4S has responded quickly to the allegations, have made referrals to the police, LADO and CQC, and suspended 9 staff. The Home Office has suspended a member of staff (who worked for G4S earlier in the year and is included in the allegations).

Our line will remain that we expect the highest standards from our contracted staff, that derogatory and unprofessional behaviour is not acceptable.

I would be grateful if you would hold the timing and content of this programme in mind in planning for the coming weeks. Please review your weekend arrangements, and plan against unexpected internal and external pop-up protest. Alan Gibson will keep an operational overview, and hold daily operational meetings from Tuesday onwards, and be talking to centres before then. It would helpful if you could think about your nominee now. Usual calls, such as managing exceptionally disruptive detainees, will continue.

Please could you also prepare your press offices for contact with the Home Office and G4S, so that we can share our respective responses quickly, and judge the degree of follow-up action. We expect BBC news to run with the story as well as Panorama, and they will be looking to find stories across the detention estate.
