
Detainee D1527 I has been relocated to Care and Separation Unit on rule 40 after jumping on Delta Wing netting. Mr D1527 removed himself after approximately 30 minutes, he went to a friends room to calm down. I spoke to Mr D1527 about his behaviour and the consequences of his actions, he refused to comply with the instructions given. Mr D1527 was already on an ACDT and has a previous significant history of self harm and suicide attempts, he started to get irate and started to fiddle with his pockets and refused to empty out his pockets or remove his hands. Fearing he potentially had something he could harm himself with or others force was used to prevent this and relocate him to Eden Wing. He was placed into E 008 and watched constantly for a couple of hours after the use of force, A full search was also conducted and nothing was found
