However \D1077 has still not eaten and therefore remains on a food and fluid refusal.

I informed <u>D1077</u> that Karen Churcher had asked that he be moved to Eden wing for closer observations in regard to his food and fluid intake. prozz agreed but stated he wasn't able to walk as he felt too weak. I offered him the use of the evacuation chair and he agreed to use this. To protect D1077 a dignity I have decided to move D1077 at 17:00 lock down so that the other detainees do not see him being moved to Eden wing.

As a case review team we agreed to alter the level care to 3 conversations per day at meal times to encourage D1077 to eat and drink plus 2 night observations.
