 FURTHER TRAINING IN C12. I AM BEING

ISSUE 2:

DT Do you recall the incident in question
 DW Yes, I remember bits of it, He was fighting + shouting throughout. Anne A was from Mr. D. Webb Road to Mr Webb.
 I had an arm, and yes he was screaming loud, so yes the noise may have carried across the chair/entrance as the course was over. In regards to hurting the detainees arm I may have said something as I know C+R hurts if applied correctly. Having cautious scenarios involving C+R + having no confusing my instructors course.
 I don't recall specifically talking about the restraint, however it may have been said following the incident in either way be described as "locker talk" meaning it may have been said but not in front of detainees as this would have been wrong.

DT ISSUE 3.

Do you recall having this conversation in this manner, At the time Dave Lister I was preparing for my instructors course I may have mentioned that if a detainee attempted to assault you in that room, by trying to get passed you, this is when you should put hands on assault the detainee in an attempt to prevent escape

J.H Can you tell me what Egon Wiley was in function.

DW It has CSO. Care + Supervision Live 40 constant watch detainees. Remains from Association. Detainees at Miramar.

J.H Is it fair to say Egon Wiley hases some of the more professional + vulnerable detainees.

DW Yes that's it, but it also allows for certain 121 interviews as the units are split in number and we have 2 staff at Egon, 1 on CSO. and if constant watches are on more staff again
