

The officer believes he is being used as a 'guinea pig' to try out the drugs that are trafficked in. He has been socialising with detainees that are known to be drug users or dealers. He has been cleaning tables even though he is not a cleaner and his roommate has stated the cleaners get him to do this so they get paid but don't have to work and they give him biscuits and other food items. The officer has seen detainees take his plate and cutlery from him in the meal queue and he does not say anything. He has also been seen being used as a messenger for detainees not residing on the wing who have treated him in an abusive manner and have been seen to clutch him round the neck forcing him to go back with messages. He was seen by an officer being asked to get a phone from someone and was then seen demanding the phone as requested.
