## Content of Report

At about 1340 hours on Tuesday 20<sup>th</sup> JUNE 2017 I was working on Eden wing, working a shift 0745hrs until 2115 hours. At this time I left the wing, and as I did I saw a detainee I now know to be **D1275** squatted down by the 'A' wing door and was attempting to pass something under the door. I took hold of the item which was a piece of paper - coloured in - and had some writing on it. I asked him what this was and who he was giving it to. He was very ~~aggressive~~ aggressive and tried to snatch it from me. He would not say what he was doing and who it was for - he just said it was his. I then said if it was his why was he passing it under the door. He just swore at me and walked off.

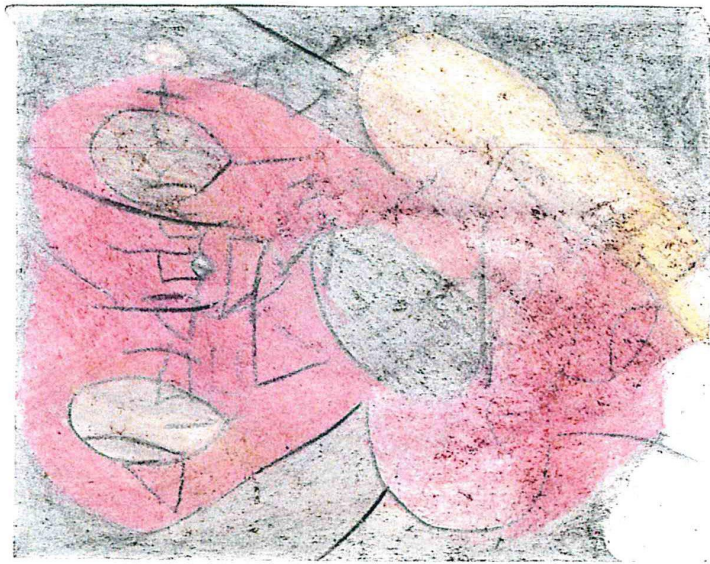

The following has been submitted on an SIR regarding the above named detainee

D1275 *appears to not be in a positive mental state. The officer believes he is being used as a 'guinea pig' to try out the drugs that are trafficked in. He has been socialising with detainees that are known to be drug users or dealers. He has been cleaning tables even though he is not a cleaner and his roommate has stated the cleaners get him to do this so they get paid but don't have to work and they give him biscuits and other food items. The officer has seen detainees take his plate and cutlery from him in the meal queue and he does not say anything. He has also been seen being used as a messenger for detainees not residing on the wing who have treated him in an abusive manner and have been seen to clutch him round the neck forcing him to go back with messages. He was seen by an officer being asked to get a phone from someone and was then seen demanding the phone as requested. The officer does not feel he is aware of some of his decisions and is being taken advantage of*

The officer has been spoken to and asked to open an ABS, but it appears this has been going on for some time unreported
