Content of Report

Whilst on an escort with detainee **D1914** to East Surrey Hospital, with DCO S. Milliken and DCO L. Blake. The time was approximately 1530-1545. We had been waiting with the detainee in the Acute Medical Unit, to see a doctor. Mr- **D1914** had been dozing, but when he woke up, he began to make remarks about how long we had been waiting. I asked him to keep his voice down, as he appeared quite agitated. He then raised his voice and was heard quite clearly to say 'fuck' and 'shit' a couple of times. This was distressing the other patients, and ~~the~~ I made the decision to terminate the hospital visit. Whilst walking along the corridor, the detainee was heard making a threat to DCO L-Blake. He said to him 'come here, and you'll see what I can do'. We continued walking back to the car, and returned to Brook House without further incident. This concludes my report. _____

Content of Report

On 17th May 2017 at approximately 1600 hours I was on a hospital escort with DCOs D. Booth and L. Blake waiting in the Acute Medical Unit waiting room at East Surrey Hospital with detainee **D1914**. Detainee **D1914** abruptly became abusive towards DCO D. Booth after it was explained to **D1914** that he is not allowed to go outside for a cigarette as we are waiting for the doctor to see him. **D1914** shouted a number of profanities at DCO D. Booth including "Fuck Off" and "You bitch, fuck off". Attempts were made to calm **D1914** down but these were met with further abuse. It was decided to terminate the escort and return to Brook House due to his behaviour. When leaving Acute Medical Unit to return to the company car **D1914** made a threat towards DCO L. Blake, saying he will show him what he can do. **D1914** was told that this is not acceptable behaviour. This concludes my report.

ON WEDNESDAY THE 17 5 17 **D1914** WAS ESCORTED TO EAST SURREY HOSPITAL BY MYSELF DCO L BLAKE DCO D BOOTH AND DCO S. MILEKAM FOR A SCAN ON HIS LEG THAT GOT DOWN AND THE NURSE SAY THAT WE SHOULD TAKE HIM ROUND TO THE A.M.U. WAITING ROOM WHERE WE SAT FOR ABOUT A HOUR AND A HALF TO TWO HOUR HE WAS A SLEEP MOST OF THE TIME HE THEN WAKE UP AND START TO GET ABUSIVE AND SHOUTING WHY HE WAS NOT SEEN DCO BOOTH ASK HIM TO KEEP HIS VOICE DOWN BECAUSE THERE ARE OTHER PEOPLE WAITING AS WELL HE THEN CALL DCO BOOTH A BICH AND STARTING TO SHOUT SO BEFORE IT EXCCITE MORE WE DISIDE TO TAKE BACK TO BROOK HOUSE WHEN WE GOT IN THE CORRIDOR HE SAID TO ME DCO L BLAKE DO I NO WHAT HE COULD DO I SAY TO HIM I AM NOT INTERESTED WHAT YOU CAN DO TO ME WE ARE TAKING YOU BACK TO BROOK HOUSE SO HE ~~STARTED~~ STARTED TO SHOUTING AGAIN AND A LADY CAME OUT OF ONE OF THE OFFICE A ASK HIM TO KEEP HIS VOICE DOWN AND HE SMILE AT HER ALSO SO HE WAS TAKEN BACK TO BROOK HOUSE
