Content of Report

1. D.C.O. BAEWSTER was informed today that by detainee D643 7187809 from Sensitive/Irrelevant that the behaviour of fellow detainee D2953 is having a detrimental effect on his health. D2953 12354885 is constantly banging his room door during the day but mostly at night.

D643 suffers from PTSD and the constant banging is upsetting him and annoying him keeping him awake. He states he is feeling uptight and asks that we do something about this behaviour of D2953. D2953 is always walking around in just his boxer shorts which annoys alot of detainees in the lunch/dinner queue. Also D2953 is constantly pressing his call button once locked up for lunch and dinner stating issues regarding fixing. He has repeatedly been told the same answers but refuses to listen. His behaviour is risking the welfare of another detainee and putting himself at risk from angry detainees by walking around in his boxers. Despite being told many times to cover up. This concludes my report.
