I Detainee Custody Officer Babatunde Fagbo (staff number: 758749), currently work at Brook House Immigration Removal Centre Perimeter Road South Gatwick. I was back for my first shift of three yesterday after having two days off. on route to rounding up detainees for their home office appointment, I was cornered by detainee D119 stating that a colleague told him I was the reason he's on close visits calling me a snake and a cocoanut calling me a sell out, I asked whom the officer was and he won't tell me, he said he swore not to disclose who the officer was. I said in that case don't accuse me of some I didn't do and in future get your facts right before you start point a finger at people. He has also been tell other detainees about the whole issue and every time I walk past them, they kept on calling me 'slave' he works for the slave and he thinks he's important. Last night we were told to go to D wing and assist with lockdown. As soon as I got on the wing and D119 spotted me he started again calling me name saying that he hopes my son has a car crash and die. I am not happy with the fact that a member of staff has gone behind my back to tell lies about me and cause unnecessary conflict between me and the detainee in question. Even if I did happen to put in a report regard D119 what happens to confidentiality?
