CONTENT OF REPORT

D1275 appears not to be in a positive mental state and seems to be vulnerable and I believe has been taken advantage of on C wing. I believe that people are using him as a kind of 'guinea pig' to try out drugs as I have seen him socialise with detainees known to be active drug use dealers. Also at one point he was cleaning the tables downstairs and he isn't a cleaner so having questioned his roommate about this his roommate says that there are detainees getting him to do the cleaning while they get paid and in return giving him biscuits and other food items. He has heard this from his roommate. Have also seen people taking his cutlery and plates whilst at the food queue and him not saying anything. **D1275** has been seen used by as a messenger by several detainees not on this wing where they have treated him in an abusive manner often clutching him by the neck and forcing him to go back and forth with messages and was seen by another officer being asked to get a phone and demanding for this phone for another detainee. We don't feel that he is aware of some of the decisions that he makes and he does get along with the Iranians in room C019 and his roommate does try to look out for him but we do think he could possibly be taken advantage of.

The following has been submitted on an SIR regarding the above named detainee

D1275 *appears to not be in a positive mental state. The officer believes he is being used a pig' to try out the drugs that are trafficked in. He has been socialising with detainees that are known users or dealers. He has been cleaning tables even though he is not a cleaner and his roommate has si cleaners get him to do this so they get paid but don't have to work and they give him biscuits and oth items. The officer has seen detainees take his plate and cutlery from him in the meal queue and he do anything. He has also been seen being used as a messenger for detainees not residing on the wing wh treated him in an abusive manner and have been seen to clutch him round the neck forcing him to go messages. He was seen by an officer being asked to get a phone from someone and was then seen del phone as requested. The officer does not feel he is aware of some of his decisions and is being taken a*

The officer has been spoken to and asked to open an ABS, but it appears this has been going on for som unreported
