The TASCOR escorts said that Mr. D87 had stated "When I get bail on Monday, I will come straight to Brook House and come for Duty Director Steve Skitt and Duty Director Michelle Brown." TASCOR escorts stated they have submitted reports in accordance with their procedures.

FURTHER INFORMATION:

Mr. D87 was at Brook House between 22/03/2017 and 14/07/17. Mr. D87 was placed on Rule 40 (removal from association) for making threats to take staff hostage, and also made direct threats to staff during this time, as well as injuring officers during a planned intervention which you have already been made aware of. Mr. D87 was also on a constant supervision ACDT has he had previously tried to put a ligature around his neck in an attempt to self-harm. Mr. D87 has an extensive history of violent and threatening behaviour and is also a MAPPA 1.
