JR – Not said to me, but to the person with me. They refused to lock up. Babs raised his voice, saying "get in your room so we can go, stop wasting time", or something along those lines. Then [D119] sat on the pool table and said he would not "just because you have told me too". They were arguing, but I can't remember what was said. They were arguing with each other, I can't remember what was said. D119 said "you think you're quite important like" and Babs said "if you don't go in your room, you are going to the block". D317 was dancing and faffing around in the background, backing D119 up, telling him to carry on what he was doing. He was taken away. In case he attacked Babs MB - Did you think he would attack Babs? JR - No. But I have a good rapport with him. MB - Why do you have a good rapport with D119 JR - I work on D wing a lot so I deal with him, I play football with him in the courtyard, I see him a lot. MB - Did you hear D119 swear? JR - Yes. MB - Did Babs swear at D119 ? JR - Yes, like "get in your fucking room". MB – Were there any gestures towards D119 from Babs?
