DRAFT Witness statement of Husein Oozeerally

I provide this statement in response to a request under Rule 9 of the Inquiry Rules 2006 dated 14/11/2021. I have been authorised by DoctorPA Ltd (42 Kew Court Richmond Road, Kingston Upon Thames, Surrey, KT2 5BF) to provide this witness statement.

- 1. My role within DoctorPA Ltd is that of a Qualified General Practitioner (medical doctor) and a codirector in the company. As such this gives me first-hand knowledge the day to day running of the company (resourcing and training GPs to work at Gatwick IRC).
- 2. As the director of the company alongside Dr Saeed Chaudhary (co-director) we are involved in the training and supervision of GPs who work at Brook House.
- In 2017 the contractual and/or commissioning arrangements between the Home Office, G4S
 Health Services, the NHS and DoctorPA Ltd for the provision of training to healthcare staff at
 Brook House are as follows
 - a. The Healthcare service is an NHS commissioned Service, on behalf of the Home Office and delivered by G4S. DoctorPA Ltd is a subcontractor of the G4S and delivers the GP component (provision of GP) of the Healthcare. Doctor PA Ltd has responsibility for the GPs working at Brook House IRC and ultimately work within the Corporate governance of G4S Healthcare.
 - b. GPs will have an induction to working within the IRC, which includes Adult at Risk training, Rule 35 training and ACDT training. There will also be ongoing supervision and training and remote support during the shifts, as well as 6 monthly appraisals.
- 4. Currently, the contractual and/or commissioning arrangements between the Home Office, Serco, the NHS and Doctor PA Ltd for the provision of training to healthcare staff at Brook House are the same as set out in 3(a) and (b) above.
- 5. DoctorPA Ltd is not involved in training at a high level or in the provision of training at Brook House other than that stipulated above so has no interaction with G4S Health Services regarding this.
- 6. I set out below a list of DoctorPA Ltd employees, their qualifications and their roles / job titles in 2017 and those within the last 12 months and currently –

GPs are given informal induction into Healthcare within IRC and there is ongoing support throughout the working day.
- 9. DoctorPA Ltd has not been involved in any audits relating to quality and outcomes of training of healthcare staff at Brook House IRC in 2017 and in the last 12 months.
- 10. DoctorPA Ltd provides no other services other than that of a subcontractor of G4S Healthcare at Gatwick IRC and provide GP services (the provision of GPs to site).
