Notice of Change 121 – 60 Additional Beds

By this letter I give notice to you on behalf of the Authority that pursuant to Clause 13 of the Contract (Changes), the Authority requires you to alter the extent of the Service Provider's obligations under the Contract as set out in this Notice of Change.

I am in receipt of your Service Provider Change Request (Form A) 089A of 25th January 2017 with regards to the provision of an additional 60 detention spaces at Brook House.

The increased capacity at Brook House will be **508** beds which will take effect from 1st April 2017 (or from the date that the beds become operational whichever is the sooner). The revised annual operating fee shall be **£12,319,968.37** per annum as set out in your Service Provider Change Request (Form A) and as set out in the table below;
