Firstly to update you; the disciplinary hearings related to Messrs Webb and Riggs were held today. Both have been summarily dismissed. Turning to Dave Webb specifically. I regret my research into his retraining has come to a very unsatisfactory conclusion. It does seem that it was related only to his (re) accreditation as a C&R Instructor as it was believed that training would inculcate the necessary insights and standards. Such a view was, in my opinion, flawed from the outset as, sadly, it has turned out. As a result of the past week we are now revising the selection and reaccreditation of Trainers and will also be moving to the videoing of all training sessions. I realise this is "stable door" stuff and can only apologise for the lack of retraining of Mr Webb - I am as frustrated by that as you will be. Regards. Jerry
