

Summary of CCTV recordings: Brook House IRC, IT room, 3 June 2017.

Recordings from one (1) camera located inside Brook House IRC IT room, descriptions taken from aspect of recording, facing entrance door.

Camera identified as:

2152 Activity Room 1: Recording start - 10:19:46 (decimals not included) internal view toward IT room entrance door.

- 10:19:46 – Several detainees in view, all sitting down. D1538 is visible sitting in lower left corner of image, he appears to be working at a computer although the unit is not actually visible. DCO desk edge just visible at middle left side of image. Two detainees sitting in centre of image appear to be looking toward DCO desk.
- 10:19:47 – D1538 looks toward DCO desk and raises his right arm toward the desk.
- 10:19:48 – D1538 lowers arm but remains looking toward DCO desk.
- 10:19:49 – 10:19:51 – D1538 raises right hand to his face then extends and raises his arm toward DCO desk, leans forward slightly. Appears to be talking and gesturing toward DCO desk.
- 10:19:51 – 10:19:56 – D1538 lowers arm but appears to still be talking toward DCO desk, swings round in chair so body is facing toward DCO desk.
- 10:19:56 – DCO Fiddy (OF) enters room carrying what appears to be a mug in his left hand. D1538 leans further forward, head just goes out of image.
- 10:19:57 – OF walks into room, appears to be looking toward D1538. D1538 sits upright and turns head toward D1538.
- 10:19:57 – OF halfway across room still looking toward D1538. D1538 turned slightly back toward computer looking toward DCO desk.
- 10:19:59 – OF continues walking toward DCO desk but now not looking at D1538. D1538 continues looking toward DCO desk.
- 10:20:03 – OF stood at side of DCO desk, upper body out of image. D1538 still looking toward DCO desk.
- 10:20:04 – D1538 stands up and strides toward DCO desk, arms swinging at his sides. OF still standing at DCO desk.
- 10:20:06 – D1538 very close to OF. OF turned toward D1538 but face not in image.

10:20:07 – [D1538] standing close to DCO desk edge and OF.

10:20:12 – [D1538] still standing close to DCO desk, now moved slightly to front of desk. All other visible detainees now looking toward DCO desk.

10:20:16 – [D1538] still stood at front of DCO desk, OF still stood to side of desk. Detainee (D1) in lower left corner of image stands up.

10:20:19 – [D1538] turns to his right and starts to walk away from DCO desk.

10:20:21 – [D1538] away from DCO desk but half turned toward [D1538] D1 walking toward centre of room looking toward EH and OF.

10:20:23 – [D1538] has back toward DCO desk, appears to be listening to D1 who is now stood in front of him. Both have passive postures. [D1538] continues away from DCO desk and D1 places his right hand on [D1538] middle back.

10:20:14 – [D1538] stops in centre of room and turns to his left, D1 has lowered his right arm. [D1538] appears to be talking to/with detainee (D2) sitting at left hand side of computer desk visible in centre of image [D1538] has both arms raised to shoulder height and held wide as if explaining or appealing.

10:20:26 – [D1538] turns to his left and faces DCO desk again, still looking at D2 and appears to still be talking to him.

10:20:27 – [D1538] still in same position, appears to gesture toward DCO desk twice with his left arm, still appears to be talking with D2.

10:20:29 – [D1538] turned to his right and facing D2, still appears to be talking to D2. D2 raises his right hand and index finger as if making a point to [D1538] D1 still stood in centre of room near [D1538]

10:20:30 – [D1538] still stood in centre of room now looking at DCO desk appears to indicate toward DCO desk with his right arm, D2 now has open right hand raised at shoulder level toward [D1538] D1 still stood near [D1538] in centre of room.

10:20:31 – [D1538] turned away from DCO desk and walking back toward his chair. D1 appears to place his right hand on [D1538] back again.

10:20:35 – [D1538] and D1 at their computer seats, D1 is on [D1538] left hand side.

10:20:37 – [D1538] and D1 both sat on their computer chairs.

10:20:39 – [D1538] appears to be talking to D1 and gesturing toward DCO desk with his right arm.

10:20:41 – D1 mainly out of image but his right hand can be seen on [D1538] shoulders and then raised toward DCO desk with open palm outward. Detainees in centre of image looking toward [D1538] and D1.



- 10:21:06 – [D1538] still sat on chair turns his head and looks toward DCO desk.
- 10:21:10 – [D1538] stands up and strides toward DCO desk, his arms are not raised.
- 10:21:12 – [D1538] stood in front of OF at side of DCO desk.
- 10:21:13 – [D1538] steps closer to OF stood at side of DCO desk. OF raises his left arm to [D1538] chest. [D1538] stood close to OF but appears to be looking toward DCO desk, not directly at OF who is stood to side of desk.
- 10:21:14 – OF appears to have pushed [D1538] away with his right hand, open palm. [D1538] steps backward away from OF.
- 10:21:15 – OF has his right arm raised to shoulder level finger pointing at [D1538]. [D1538] has his left arm raised, appears to be pointing toward DCO desk. [D1538] appears to be talking to OF.
- 10:21:15 – [D1538] steps toward OF, both visible looking at each other, arms are in same position, both raised. OF has open palm.
- 10:21:16 – [D1538] steps toward OF again, OF pushes [D1538] away again with his right hand, palm open. [D1538] takes a step backwards away from OF. [D1538] appears to hold OF's right arm with his left hand and pull OF forward. D1 stands up again.
- 20:21:17 – OF and [D1538] close together. [D1538] appears to have his right arm raised over OF's left shoulder and is leaning toward him. OF has a defensive posture and has his right arm raised between himself and [D1538] at chest level.
- 20:21:17 – [D1538] and OF now face to face. [D1538] has his right arm raised over OF's left shoulder. OF has his right hand visible at [D1538] left shoulder, palm appears to be open.
- 10:21:18.24 – OF appears to be pushing [D1538] away with his right arm to [D1538] left shoulder area. [D1538] appears to have his right hand at OF's left neck area. D1 walking toward centre of room again. Second DCO appears in image from behind DCO desk.
- 10:21:18.74 – OF has pushed [D1538] away, [D1538] stepped backward away from OF. DCO Instone-Brewer (OIB) now fully in image stood next to OF.
- 10:21:19 – [D1538] steps forward toward OIB but looking at OF. Detainee (D3) stands up from his chair at right hand computer in centre of image.
- 10:21:20 – [D1538] continues toward OIB. OF moves to his right and stands between [D1538] and OIB. D1 moves closer toward the group.
- 10:21:21 – OF appears to raise his right arm between himself and [D1538]. [D1538] raises both his arms to shoulder level between himself and OF. D1 now stood directly behind [D1538].

10:21:22 – [D1538] stood facing OF and OIB, D1 now at left side of [D1538] and moving between him and DCOs.

10:21:23 – D1 stood between DCOs and [D1538] facing [D1538] [D1538] still appears to be looking toward OIB.

10:21:24 – D1 has his hands on [D1538] waist and is moving him backward away from the DCOs. D1 looks toward D3 who is still standing by his chair.

10:21:25 – [D1538] moves sideways to his left apparently attempting to approach OIB. [D1538] is still looking at OIB and leaning slightly forward toward him.

10:21:26 – [D1538] is moved backward away from DCOs by D1. [D1538] is still looking at OIB and raises his left arm to point at OIB.

10:21:28 – D1 has his right arm around [D1538] back and continues to move him away from the DCOs. OF has his both arms at waist level in front of OIB. [D1538] and OIB appear to be staring at each other. D3 sits back down in his computer chair.

10:21:29 – OF moves OIB backwards, D1 moves [D1538] backwards. D1 and OF have their backs to each other.

10:21:32 – OF and OIB back by side of DCO desk. D1 still facing [D1538] and appears to be talking to him.

10:21:36 – Both DCOs still by DCO desk. [D1538] moves to his right into centre of room, D1 moves with him, appears to be keeping himself between [D1538] and DCOs. [D1538] pointing toward DCOs with his right arm raised to shoulder level.

10:21:38 – [D1538] moves against D1 as if to get past D1's restraint.

10:21:40 – [D1538] appears to be attempting to walk toward DCOs but D1 holds him back. Detainee (D4) sitting at computers in centre of image appears to be talking to [D1538] [D1538] is looking at D4 but still pointing toward DCOs.

10:21:45 – DCOs still stood by side of DCO desk, OF looking toward OIB. D1 continues to talk to [D1538] and appears to hold him in place. [D1538] looking over D1's right shoulder toward the DCOs. D2 stands up from his computer chair.

10:21:49 – [D1538] has moved to his left, still looking toward DCOs, D1 moves with [D1538] to stay between him and DCOs. D2 walking over to [D1538] and D1. DCOs still stood at DCO desk.

10:21:50 – D1 and D2 now with [D1538] D1 has hands on [D1538] right rear shoulder. D2 has hands at chest level, open palms toward [D1538] [D1538] moving to his right toward door.



10:21:52 – D1 and D2 now crowded [D1538] toward door, both have hands on [D1538] and appear to be talking to him.

10:21:55 – D1 and D2 now crowded [D1538] to the door, DCOs still stood by side of DCO desk, OF not looking toward [D1538] OIB face not in image.

10:21:56 – D2 turned away from [D1538] and walking back toward DCOs. [D1538] attempting to move past D, [D1538] looking at DCOs, left arm raised slightly. D1 places his right arm across [D1538]s chest as if to restrain him. [D1538] looking toward DCOs, leaning forward, head forward and appears to be talking/shouting at DCOs. OF turned toward [D1538] slightly in front of OIB. OIB is still stood at side of DCO desk, legs crossed, face not in image.

10:21:57 – [D1538] has pushed past D1 and is pointing with his left arm toward the computers lower left of image, [D1538] looking at D1. OF has moved further in front of OIB as if protectively, looking toward [D1538]

10:21:59 – [D1538] moves to his original computer chair and sits down. D1 follows him. D2 now back at his computer chair but still standing. DCOs not moved.

10:22:01 – [D1538] sat at computer. D1 looking toward DCOs and appears to be talking to them.

10:22:04 – D1 moved toward DCOs and stood with them, relaxed posture, OF turned away from D1, D2 moving toward DCOs.

10:22:06 – D2 now with D1 talking to DCOs, OIB still at side of desk legs crossed. OF moved behind desk out of image. [D1538] half risen from his chair and is pointing toward DCO desk with right arm raised to shoulder height.

10:22:11 – D2 moves away from D1 and DCO desk toward his computer chair. OIB still at side of desk with D1. [D1538] still in his chair, looking toward DCOs but arm now lowered.

10:22:16 – D2 now sat down [D1538] still sat down, turned toward and looking at computer. D1 still at DCO desk, OIB now moved behind desk out of image.

10:22:27 – D1 moved away from DCO desk and returned to [D1538] appears to be talking to [D1538] [D1538] still sat looking toward computer.

10:22:41 – [D1538] still seated but now turned round to face D2 who he appears to be in conversation with.

10:22:43 – D2 now stood and walking over to [D1538]

10:22:50 – D2 now stood behind [D1538] who has turned back to computer. As D2 walked across the room his body language and gestures appeared to be conciliatory.

10:22:57 – D2 still stood talking to [D1538] [D1538] now stood facing D2.

10:23:07 – D2 still stood by [D1538] and still talking to him. [D1538] now sat again and D2 has his hands on [D1538] shoulders.

10:23:12 – D2 moves away from [D1538] walks back to his chair.

10:23:17 – D2 sat in his chair. [D1538] still sat and looking toward computer.

10:23:37 – [D1538] sat at computer and appears to be typing at keyboard.

10:23:37 – 10:24:30 – No relevant activity. General movement of detainees and OF around room. [D1538] remains sat in his chair, occasionally looking around.

10:24:30 - OIB moves from behind DCO desk into image.

10:24:33 – OIB in centre of room, OF walking toward left of room near D2, [D1538] sat in chair, door open and DCM stood in door way.

10:24:39 – OIB stood in centre of room pointing toward [D1538] [D1538] sat looking toward OIB. OF stood at side of DCO desk not facing the room. DCM stood in door way looking toward OIB.

10:24:50 – DCM and OIB moved out of room, [D1538] sat in chair now swung round to face door. OF stood at side of DCO desk facing room.

10:25:10 – [D1538] stands and walks toward OF who is stood by side of DCO desk. [D1538] posture looks relaxed, arms down by his sides.

10:25:15 – [D1538] appears to say something to OF then turns away and walks back to his chair and sits down.

10:25:15 – 10:25:38 – [D1538] and OF appear to be in conversation.

10:25:38 – [D1538] stands up and walks to OF. [D1538] appears more agitated and stands very close to OF, face to face. Appears to have right arm raised to waist level.

10:25:45 – [D1538] turns away from OF. Door opens, OIB and DCM visible through opening and window.

10:25:49 – [D1538] walks across room, looking at OF, toward door, appears to have been requested by OIB who briefly entered room.

10:25:52 – [D1538] exits room through door.

10:25:52 – 10:27:51 – No relevant activity.

10:27:51 – OF leaves room through door. DCM and [D1538] briefly visible through open door.

10:27:51 – 10:28:49 – No relevant activity.

10:28:49 – OF enters room through door.

10:28:49 – 10:30:04 – No relevant activity.
