

I Am DCM Dave Roffey currently employed as a DCM (oscar 1) at Brook house IRC.
On Friday 07/04/2017 DCM Attwater was called to D wing as detainee D523 CID 5859573 was refusing to lock up at 21.00 He said that he will not share a room. DCM Attwater eventually had no choice but to remove D523 from association. When he was taken to the CSU he became abusive to DCO Francis telling him he was a "Deadman". D523 was searched into room 002 on the CSU. When I later took his paperwork for rule 40 to him he became abusive towards me saying "big man you are Gay" "you piece of shit". D523 has spent some of his time since being on rule 40 kicking his door and shouting at other detainees on CSU. This concludes my report.;
