We continue to represent the above named Applicant in his Immigration Matter. Please would you continue to forward all future correspondence in this matter?

We are in receipt of the Home Office impugned decision letter dated 10 April 2017 to make a Deportation Order for the above named Applicant.

Meanwhile, we have been informed by the Applicant's partner that the Applicant suffered from a heart attack last night whilst in detention centre. The Applicant has been transported to East Surrey Hospital Gatwick to receive urgent medical attention. Since the client is in detention, we believe that it is the Home Office's responsibility to provide full medical care and attention to the Subject who is also a heart patient. Please confirm that the medical authorities are taking good care of him and that he is in safe hands. Kindly also confirm what measures are being taken to prevent such stroke/attack from happening again?

It is important to mention at this stage that we previously informed you about the delicate health and position with regard to the Subject's medical heart condition and medication that he regularly takes. It is now clear that the detention conditions are not suitable taking into account the Applicant's poor health condition. It is needless to indicate that the Subject was subjected to extreme amount of anxiety and stress that he suffered a heart attack in present conditions.

In light of the above, we request that the Subject be released immediately and he should not be returned to detention centre specially after suffering a heart attack as he cannot sustain the hardship of the detention centre. This is for the betterment of the Subject's health and life.

Lastly, we would like to inform you that we will be pursuing the matter into the Courts & Tribunal and have submitted the Appeal [IAFT5] under Regulation 36 of the EEA Regulation 2016 against the Home Office impugned decision dated 10 April 2017.
