Re: Further representation on Medical Condition

I am writing you regarding further representation on my medical condition. Whilst I am aware that you have been previously informed of my medical condition, it is has imperative to put you on notice of the exceptional circumstances surrounding my medical condition which requires your anxious scrutiny and unbiased consideration.

As you know and aware of my service in the Military, where I served with dedication and received meritorious awards for my engagements in the HM Forces during which I dutifully served this Country.

However, I was medically discharge from the Army and diagnose With PTSD (Combat Stress) which was as a direct result of my involvement with the British Army.

Time and time I again, I have been asking for help from you medical practitioners to addressed my mental health issues. But they don't give any help to me, instead they told me to contact my case worker.

Continued detention is making my mental health more injurious, I am struggling with some of the detainees from Iraq and Afghanistan. When they wear their culture dress and when they made they screams and talk in Arabic language. It remind me of being on the front line and therefore triggers my PTSD symptoms. Loud bagging sounds, unexpected noise, screaming, and bagging on the doors at night add to the nightmare and made life difficult for me in this detention. I am struggling to coup with very day life in detention.

I have put this argument to you before. Even your medical practitioners told you that continue detention is making my mental health more injuriously. I am on medication for my mental health but it is not taking me away from all of the PTSD triggers am getting in this detention. So please I asking you again to take me away from this situating that is damaging my mental health.

Please note, that I am also aware you stated previously in your correspondence that I can access mental care for my PTSD Combat Stress condition in St Vincent and the Grenadines. But I have evidence from the Minister of Health St Vincent and the Grenadines, and St Vincent and the Grenadines foreign office through St Vincent and the Grenadines commission that says that the help is not available there.

In your decision letter Refuse a Human Right Claim 15 June 2016 on page 4 you stated. In your letters of 13 June 2016 and 14 2016 you have reiterated the fact that you client suffers from non freezing cold injury and post traumatic stress disorder(PTSD) and receiving treatment. It is noted that these matters were previously raise in your letter before. In the absence of any new evidence it is reiterated that your client will be able to access medical care when he returns to St Vincent and the Grenadines.

I now have fresh new evidence to support that facts, and I will provide it with this letter.

Again in a monthly report 26 August on page 2 under <u>Treatment received, duration and life ceasing any treatment</u>. With this letter I will provide new evidence on treatments that was proscribe for me by consultant psychiatrist professor Fox, in his psychiatrist report.

In psychiatrist Dr Kevin Wright J.R report 5 December he said I am suffering from severe form of depression and PTSD as a result of my service to the army he conforms my condition

Professor Fox and Dr Owen Davis also conform my PTSD condition, both of them along with two of your own medical practitioners conform that continued detention is damaging, injuriously and deteriorating my mental health.

Removing me to St Vincent and the Grenadines will have a serious psychological impact and my daughter and the immense damages my PTSD have on me, it will be best if it treated in the UK where I get my condition serving for this Country. Professor Fox, Dr Owen Davis and Dr Kevin Wright J.R conform this.

You have also failed to realise the impact that removing me to St Vincent will have on my daughter, Dr Kevin Wright explained this in his report, but you have fail to recognize my daughter health and put deportation before my daughter health.

Dr Kevin, Wright Professor Fox, and Dr Owen DAVIS concludes that I should be offered the opportunity to receive the best/ treatments that Britain has in helping veterans receive
