The information in this schedule has been extracted from documents held by the IMB, specifically the application forms, any documents attached to those forms and the IMB's log book of applications.

IMB states no requirement for further action.
834	29.3.17	D1523	Assaulted by an officer. Detainee was concerned that he is not due to receive a response to complaint from the Home Office until 20.4.17 but was due to be removed on 31.3.17.	On 29.3.17 spoke to the Home Office and was advised that the complaint concerned events at Dungavel and Morton Hall IRCs rather than at Brook House. The Home Office advised that the complaint was being dealt with and that the detainee would be informed of the outcome. This information was communicated to the detainee by letter on 29.3.17. On 26.4.17 spoke again to the Home Office who had still not responded. On 3.5.17 spoke again to the Home Office. The Home Office advised that the detainee had been deported on 29.4.17, but that a response would be sent onwards. On the same day informed that the detainee had

On 3.5.17 replied by way of letter (the detainee being at another IRC for an interview on that day) having spoken to healthcare. Advised to put in a complaint directly to healthcare.
855	26.5.17	D1486	Blood in urine and abdominal pain but the doctor was not helping. The detainee was not permitted to have his medication in his possession.	Spoke to healthcare, notified detainee by a letter dated 31.5.17 that the IMB cannot question medical decisions but that, of the medications being taken, only one is not allowed in possession because it is a controlled drug. Notes that healthcare said he had not seen a doctor, that a blood test was due to take place, and that the detainee had not attended his appointment on 29.5.17. Advised to ask for a further appointment.

On 15.6.17 advised that this was an issue best raised with G4S and that the IMB member would pass the complaint on. On 17.6.17 an email was sent to G4S requesting an explanation for the prohibition of fans and a request that the policy be reconsidered.
862	12.6.17	D1523	Linked to 834 above and allegation of assault by an officer. Previously asked IMB to deal with his concerns.	Spoke to detainee on 15.6.17, took copies of the detainee's documents and pursued the complaint with Michelle Smith and Dungavel IRC. Appear to be two incidents: an allegation that the detainee assaulted an officer at Dungavel IRC and a second

On 16.6.17 a response was received from Dungavel IRC stating that they have no record of an assault by the detainee on a member of staff, though the detainee appeared to have been involved in an assault on another detainee. On 20.6.17 the detainee was removed without warning to Spain. Further information was then received indicating that the detainee had a conviction for assault on 18.12.13 although it was unclear whether this was related to the complaint. Response from Harmondsworth IRC regarding the allegation of assault by an officer concluded unsatisfactorily. IMB liaised with Colnbrook IMB to obtain copies of complaints and responses to investigate further. A request for this information was made on 21.6.17 and a response was received on 6.7.17 which noted that the three complaints referred to do not appear to have been allocated to Heathrow IRC. On 23.6.17 the IMB received confirmation by email that the detainee's caseworker will remove any record of the assault on an
				officer by the detainee at Dungavel IRC.

This was communicated to the detainee in person on 19.7.17.

He states that doctors are refusing to give him a nasal spray for his condition.	On 5.9.17 spoke to healthcare. Healthcare advised that the nasal spray is not permitted because it is highly flammable but that the detainee should go to healthcare to be seen if he is not well. This information was communicated to the detainee by a note dated 5.9.17.
890	5.9.17	D3282	Assault by Tascor agents. Request for emergency appointment for suspected broken arm.	Spoke to healthcare on 5.9.17 and advised that the detainee was seen by a GP that morning. GP believes that the detainee has suffered a soft tissue injury and prescribed painkillers to be collected in the evening. The detainee should return to healthcare if the swelling worsens, otherwise they intend to wait three days to see if the symptoms subside before attending hospital for an x-
