4 Monthly Reports from Home Office and G4S

Lee Hanford for G4S

Talked about a difficult month for G4S month as regards staffing with increased violence specifically between Afghanis and Albanians. There was a difficult Albanian Charter. G4S is not happy with the "no notice" charters – he thinks the policy lacks transparency and affects the relationship of trust staff try to build with detainees. **PG** explained some of the policy behind this including last minute representations and that the detainees have already been given notice of a removal window.

There had been an increase in UOF much due to Mr D3442 a detainee with severe health problems. Board members noted some excellent work by G4S staff in keeping Mr safe. Lee had held a meeting with stakeholders. Topics raised included improved ways of working, low staffing and liaising with staff members about contracted hours' scheme. A few Tinsley staff had complaining of being cross deployed, but many had then applied for extra hours. Overall response has been positive and exceeded expectations. His plans included increasing front line DCM staff with an advert already gone out and appointing a senior Residential Manager. A new head of safeguarding will start on December 11th. Updated on staffing post-Panorama – of those given written warnings only one was reinstated and had his HO accreditation authorised. Has also met with the Minister, Brenden Lewis. Discussed the complications around the case of Mr (above) with Hibiscus and learnt about the Gill Dando Institute and how help can be offered to vulnerable detainees (eg those at risk of human trafficking) on their return to their home countries. The Stephen Shaw visit has been very positive all round including a very good report on Rule 40 reviews.

Kate Lampard will be on site for 3-6 months preparatory to writing a report on the centre. **Lee** mentioned an increase in searches, particularly for hooch now the festive season is approaching. Much of the centre is being re-decorated. In particular there is to be deep abrasive cleaning of sanitary fittings and the addition of inundation points for fire hoses to doors in detainees' rooms. This work, which requires a wing to be closed starts 17/11 with B wing and is hoped to be completed by 9th Jan. The IT suite is in the process of being upgraded. Lee believes teething problems have now been sorted out but will check.

GJ asked if there was a Prevent policy in Brook House to assist detainees considered vulnerable of terrorism grooming. Neither PG nor Lee was aware of one.

PG for Home Office

Spoke about the Pre Departure Team going live and how the HO will be divided in two teams - PDT and Compliance. Liz O'Brien the new SEO coming in to run the PDT team with Simon Levett the new HEO. Alec Holton covering Simon Levett's old post in compliance team as acting EO. **PG** confirmed he will be leaving his current job role as HEO Immigration Manager (expect chocolate for next meeting) and the role will be covered by Rob Gibson HEO Immigration Manager at Tinsley House until appointments are made.

The Board noted that Healthcare had failed to provide the figures required for the combined report.

EM Raised a questions about Voluntary Returns. Are detainees still able to access forms as welfare were working more directly with HO? Will that continue? **PG** Discussions are ongoing and he hopes to give an update for next meeting as it seemed to work well.

JC Raised a query about longest serving detainees, one particular detainee came up is DITOG Who is refusing to comply with ETD and High Commission interviews, so what do the HO do with detainees refusing to comply?

5	IMB issues (Statutory Visits)	
	MM w/c 16/10 - Plans for enabling faster access to Welfare? Welfare office is blocked by issues with detainees being sent to welfare when they could be dealt with by wing staff. Lee agreed and is proposing a DCO on each landing, trained to cope with some of the issues detainees raise. She mentioned her surprise at the scarcity of "bully books" and will follow this up on her rota.	Action
	GG w/c 23/10 – difficult week with staff shortages and in particular on E Wing with the problems of coping with Mr Staff remarkably caring in their attitude to him. Lee agreed there were issues around Mr D3446 and Mr D3442 and their fitness for detention – Stephen Shaw took particular interest in them. Kitchen experiencing problems – staff shortages mean that workers do not always arrive on time and trolleys are not brought back promptly.	
	JT w/c 30/10 – an application from Mr D3286 with inappropriate behaviour by a DCO led to a general discussion. Joyce had understood Mr D3286 only wanted to unburden himself of a number of things that were upsetting him, one amongst which had been the officer's behaviour. She had made full notes on his ACDT which is read by the DD and Safer Custody Manager daily and considered that sufficient in the circumstances. On reading the rota report Michelle Smith had asked about this and, particularly in view of Panorama, questioned if the board should have done more. Her suggestion was that any issue raised with the IMB regarding a member of staff should be raised immediately with G4S and the HO regardless of the severity or probability of occurance. DW thought that such a matter should have been reported to a senior manager straight away with a follow up in writing. In general the board concurred with his view.	Action Board
	LG w/c 6/11 – had been concerned that one DCO found it difficult to check ID of detainees when all were pushing through the wing door together. Lee is aware of the problem and considering options eg a turnstile, but all have their disadvantages in an emergency. IT problems already discussed above. Blanket not given to a detainee overnight? When this complaint was investigated the detainee told the DCM it was a roommate who had submitted the complaint using his name but he could not remember who and he personally had no issue. LG thought in retrospect it would have been better to follow up the upset detainee on D Wing with a referral to Safer Custody/the Oscar or at the least spoken to an officer on the wing to share her concerns.	
	JC asked if there was any news on the proposed changes to the Induction process. Lee advised this was still ongoing.	
	JC updated G4S and HO on the Board's recent visit to GDWG at their Crawley offices. A theme had been the Gatwick group felt there was poor communication. They do not understand what the Centre feels is an appropriate referral. And often they get no response when they do use "proper" channels. DW remarked on the lack of confidence between Brook House and GDWG despite the acknowledgement by all of the excellent assistance that the group provides detainees. GG said that GDWG had heard about some of the things aired in the Panorama program. Lee is proposing a meeting in the near future with their Director, James Wilson.

CHAIR'S LETTER November 2017

Dear Board Members

Panorama has continued to be the Centre's main focus – I can use the same opening phrase again – while trying to ensure that all continues to run smoothly. That goes as much for the IMB's monitoring and efficient operation as for G4S and the Home Office. Forum, IRE Workshop, Stephen Shaw Review, meeting with Michelle Smith, Second Secretary of State......it has been a busy month!

IRE Workshop

As I said elsewhere, Panorama and Brook might just as well have been the title as the subject cropped up so often through the day. Joyce, Gareth and I attended. Jane Leech said some nice things about the quality of our rota reports and I think it was Stephen Kershaw, Director of Strategy who referred to us as the still small voice reminding that not all was bad at Brook House. From my point of view James McGinley speaking about the Gatekeeper role introduced by the HO as a result of the Shaw Report to oversee casework decisions was very useful and maybe we can ask Paul to comment at the BM. Joyce may have other points to raise.

IRE Forum

This triennial meeting of IRE chairs took place as usual at the MoJ. I have already circulated notes. Panorama, of course, was a theme and there was a strong feeling of support and understanding from the other chairs. The Verne chair noted they had been asking transfers from Brook about their experiences and all bar one said their treatment had been fine. Michelle Smith was representing Alan Gibson and undertook to take forward the issue of how we can monitor litigation cases.

Stephen Shaw Review

We knew there was to be a follow up visit to Brook when Stephen would want to talk to the IMB but a final date and time was agreed only the day before, when I was at a funeral in Leeds. Having tried Dick it was really too late to ask anyone else to come along so I went alone. The main focus of his review is to see how far his recommendations of Jan 2016 have progressed. And, of course, Panorama came into it. I pulled together as much info as I could in the time a/v and we had an amiable discussion. My main point was that there had been gradual progress pre-Panorama on his recommendations (think the work on vulnerable adults; Rule 40 policy; Predeparture Team; weekly Disruptive Detainee phonecall). And then, post-Panorama the disruptive effect of staff loss, demoralisation etc etc. One thing I particularly bemoaned was the continuing absence of some more advanced mental health training for officers, especially on E wing, at the very least to bolster their confidence and self-worth as they deal with some really ill detainees. And then I listed the steps the board were taking. He was already well aware of much that was happening in the centre.

Second Secretary of State

Following Hugh Ind and Michelle's visit to our September meeting I was contacted by the Second Permanent Secretary, Patsy Wilkinson, interested in hearing about the IMB role and our working relationships with G4S and the Home Office. Dick and I are due to meet her on Monday afternoon.

IMB Publicity in Brook House

Juls has asked all departments to provide new posters for the wing noticeboards after the re-decs. It is an opportunity to rethink how we communicate with detainees. Michelle Smith had some suggestions to make and Mary and I have been looking at the present poster to accompany the mug shots. She will be liaising with Juls. The proposed email address for detainee use could also be advertised there. Dover offered help with setting one up and if anyone else has any good ideas please...... I believe the confidentiality aspect will be covered because it will be the detainees choosing what they write – it might just be a "please contact me" and telephone number. The rota person would pick it up and could simply phone back (taking precautions to protect your own number) in the first instance to see how urgent the matter is. I think it is worth a try and is a move to the tech way of doing things. There is also the idea of a mass text message "your IMB member is on site today"

Visits/Budget

Following on from the above it came as a surprise to Stephen Shaw and Michelle Smith that the number of visits board members can make to the Centre are laid down in our annual allocation. This year we were allocated 193 visits, increased by 3 for a serious incident earlier in the year. Obviously, deducting board meetings does not leave a lot for rota visits and yet the DSO on R40 talks of visits within the first 24-hours of a detainee being put on R40/42. I think I may have put the cat among the proverbial as Stephen Shaw is going to raise this with our new President Dame Anne

Owers and I expect it will be discussed in Home Office circles. In the meantime I am investigating exactly how many R40s go over the 24 hours, as our impression is that it is not many.

IMB Annual Report 2016

The Minister's answers to our recommendations were circulated and we need to dedicate a short bit of the meeting to looking at these together.

Mary is working hard on getting us into a good place to tackle the 2017 report and will be able to update us on our way forward.

Gatwick Detainees Welfare Group

This is finally due to take place at their Horley office on Tuesday. Mary, Louise, Dick, Elisabeth and Jackie will be representing us and GDWG will have five of their members as well. We will be able to see their operation and discuss subjects of mutual interest.

Les Miserables at HMP High Down
