Hello Lynn,

As far as I remember, [D130] was asked by Eden wing staff to pack his things and move to Beck wing, as there was a space up there for him. I don't remember, but he may have been a single occupant. He refused to leave Eden wing. When I arrived on Eden wing, staff informed me he wouldn't leave. I went to [D130] room and asked him to pack his things as he was required to move out of Eden wing and onto Beck wing. Eden wing was short of space and we needed to free up some rooms if possible. Whilst I spoke to [D130] in his room, he became loud, abusive and argumentative towards me and saying he wasn't going. I tried explaining why he had to move off the wing, but he continued to be non-compliant and wasn't listening to me, so I decided to leave and rethink what I was going to do next. I'm not sure how many times I mentioned his name, but at a guess, I would suggest it was 2-3 times. I probably mentioned his name 2-3 times, because he was trying to argue with me and I am trying to get him to pay attention to what I'm saying. So when he finishes shouting and being verbally abusive, I think I would have said something along the lines of, '[D130] can you listen to what I'm saying?' and '[D130] we're only asking you to move to another wing upstairs, as you can't stay here anymore'.

With regards to grabbing my private parts, I believe at the time, I was on Eden wing with Sara Edwards and [D130] had come from his room and was making various accusations towards me and Sara and possibly also saying he was going to make a complaint against us but I didn't know why. I'm sure that during this time, I was or had adjusted my workwear, ie re-tucking my shirt into my waistband or something like that. I have over time, lost weight and have found myself adjusting my clothes from time to time. I think he has misinterpreted this and I certainly wouldn't have grabbed my privates in front of him as he might be suggesting.
