109 **Jo Buss:** I don't know where he is. Is he on D Wing?
110 **Callum Tulley:** Yeah, he's been put onto D Wing, so –
111 **Jo Buss:** Right.
112 **Speaker 1:** Was he taking spice, did he?
113 **Jo Buss:** No.
114 **Callum Tulley:** No, no.
115 **Jo Buss:** Never seen anything like it. You know the observation door on E Wing? His feet were
116 going up – up the door, fucks sake.
117 **Callum Tulley:** No, I, like – because just personally, [inaudible 00:06:48:14], because, you
118 know, we were like involved in that incident. And then –
119 **Jo Buss:** Yeah.
120 **Callum Tulley:** – we weren't even told he was going to be back, allowed onto the wing.
121 **Jo Buss:** Yeah, after all that. That was a spectacular [inaudible 00:06:57:20].
122 **Callum Tulley:** Because like – but I suppose if you haven't – have you – well, we've never
123 been told anything of it, even if you've not been either.
124 **Jo Buss:** What time did – actually, what time did we finish that incident?
125 **Callum Tulley:** I don't know, maybe quarter-past-eight, half-eight? It was quite –
126 **Jo Buss:** Yeah. Thank you. I must put that on my timesheet. I'll put that on.
127 **Callum Tulley:** Towards [inaudible 00:07:12:20].
128 **Officer 1:** What was that? He – what happened then? What –
129 **Callum Tulley:** He was – he was – he didn't – like he was trying to swallow a battery. He tried
130 to strangle himself.
131 **Jo Buss:** Strangling, yeah, but a phone battery at the – those flat – a Nokia battery that he
132 wanted to swallow. But he self-strangled, then he went up the door, then he had a massive
133 hissy fit on the floor. And apparently, a couple of hours later, he was as right as rain.
