MALE SPEAKER 1: Anything else about what Yan did? Tell me again what he was saying afterwards. You've done it in bits and pieces, don't worry about repeating yourself. It just helps to (inaudible).

Talk to me about what Yan was saying afterwards again.

CALLUM TULLEY:

He was saying afterwards, Yan was saying in the wing office afterwards that he was trying to put the detainee to sleep. That's what he said to me, those were his words.

And later on when we were having this conversation and I was on constant supervision with a different detainee, well the detainee I was originally observing, Yan ... the detainee who ...

Sorry, just takes time, just let me explain it.

So later when I was on the constant supervision that I was originally on and Yan was telling me about what he and his colleagues used to get up to in Wandsworth.

The detainee who tried to strangulate himself had appeared to have calmed and he came to the cell door. And I think he asked to have a shower and an item of clothing. And Yan opened the door and went in and he said to him he would actually help him get some clothes and have a shower later on. But if he ... I think he said if he fucked about or if he tried anything else then Yan was going to do something stupid and he didn't care about his job.

MALE SPEAKER 1: Was there any paperwork filled in about any of this?

CALLUM TULLEY: So Yan said -- when I was sat back in the office later on after I'd been to the toilet and stuff. Yan came into the office and he said, "As far as we know there's going to be no use of force, it's been approved by

Dixie", which is what people call Steve Dix, one of the managers.

And then Yan did later confirm this at the end of the wing, he said,
"No, no use of force report for that, we're not going to do one".

And then later on as I was passing Charlie, they're both E wing
officers. So as I was passing Charlie as I was going off shift I said to
Charlie, "Yan said that we don't have to do use of force report, is that
right?" And Charlie said, "Yeah, no managers were present".

MALE SPEAKER 1: What does that mean?

CALLUM TULLEY: That means that there's just going to be absolutely no record of what happened in that room. And if the detainee does say anything it's going to be his word against Yan's and Charlie's. And you can probably guess who they're going to believe.

MALE SPEAKER 1: Is this the first time you've seen use of force not reported?

CALLUM TULLEY: It's the first time I've seen use of force on this scale. I mean I've never seen use of force of that scale before. And I've seen some stuff at Brook House, but I've never seen anything like that.

MALE SPEAKER 1: Just focusing on the fact that they've not reported it, is this the first time that a false record has been created at what happened to detainees?

CALLUM TULLEY: No. I have seen and heard of false records being created about use of force.

Actually I would just correct myself there and say I've seen and heard people talking about faking the use of force report. I haven't actually seen someone type up a lie. All I've heard about is officers saying that they've lied on use of force reports.

I just want to make that clear.

MALE SPEAKER 1: So I guess what I'm driving at is --

CALLUM TULLEY: There was no use of force report, there was no use of force report.

So I mean it's one thing to use force on someone and then lie on the

use of force report because the use of force has still been

documented.

But this use of force isn't going to even be documented in any way

because there is going to be no use of force reports. It's a complete

cover-up.

MALE SPEAKER 1: Anything else you want to go over? Quite important to document

Just have a little think, take a deep breath.

everything while it's fresh in your mind. Without having spoken to

anybody, do you know what I mean?

CALLUM TULLEY: Yeah.

MALE SPEAKER 1:

CALLUM TULLEY: Yeah, just give me time, mate.
