426 **Callum Tulley:** Just put in Romania - put in Romania as the country and then the first
427 name [inaudible]. Yeah, I know that mate, but -
428 **Dan Lake:** Well, we'll never know. We'll never no more than one corridor away.
429 **Male Officer:** Him? He is a nonce isn't he?
430 **Callum Tulley:** Yeah.
431 **Male Officer 2:** He's a fucking **Sensitive/Irrelevant** mate.
432 **Callum Tulley:** **Sensitive/Irrelevant** He's - he's -
433 **Dan Lake:** **Sensitive/Irrelevant**
434 **Male Officer:** [inaudible] **Sensitive/Irrelevant**
435 **Dan Lake:** I've got your back mate.
436 **Callum Tulley:** Yeah, but like if he done something to me on the courtyard you're all-
437 working visits. So, I don't think you're going to be much help up there, are you?
438 **Dan Lake:** I [inaudible] back today.
439 **Callum Tulley:** Exactly.
440 **Dan Lake:** [Inaudible].
