970 **Callum Tulley:** What about [inaudible] threats?  
971 **Dan Lake:** Yeah  
972 **Callum Tulley:** Oh, okay.  
973 **Dan Lake:** He called Sean a fat cunt and Sean went "do something about it then" and then  
974 he come over like he was going to hit Sean, Sean grabbed him and threw him in his room,  
975 went into his room and went bang at it [smirks].

977 **Dan Lake:** [Inaudible] when he's threatened someone.  
978 **Callum Tulley:** Hey?  
979 **Dan Lake:** Can't go back on association when he's [inaudible].  
980 **Callum Tulley:** No. What was his reaction? [Inaudible]?  
981 **Dan Lake:** Just [inaudible].  
982 **Callum Tulley:** Did they not – did he not get –restrained or?  
983 **Dan Lake:** Sean picked him out. I was standing next to Sean and Sean had him picked him  
984 up like this in a bear hug. [Imitates wrapping his arms round the back of someone]. Threw  
985 him in his room.  
986 **Callum Tulley:** All right.  
987 **Dan Lake:** Backhanded him and locked him in.  
988 **Callum Tulley:** Really. Was he off his nut at the time?  
989 **Dan Lake:** No, he literally [inaudible].  
990 **Callum Tulley:** Really?  
991 **Dan Lake:** Did you see Sean walk out? [Inaudible].  
992 **Callum Tulley:** No. Oh really.  
993 **Dan Lake:** [Inaudible] wrap him up but Sean bear hugged him. I wouldn't dare.  
994 **Callum Tulley:** Did he give him a proper smack?  
995 **Dan Lake:** Yeah, backhander right on his face. [Inaudible].  
996 **Detainee 2:** [Inaudible].  
997 **Callum Tulley:** Why did he, why did he Sean do it?  
998 **Dan Lake:** Angry. Called him a fat cunt [inaudible].  
999 **Callum Tulley:** Why's he saying that to him?  
1000 **Dan Lake:** I don't know, he's just had a beef throughout the day. [Inaudible]. He was like "I  
1001 want to go back to B wing", and Sean went "stop smoking that fucking spice then" and he  
1002 just went "shut up you fat cunt". Sean just lost it.  
1003 **Callum Tulley:** Did he?  
1004 **Male Officer 1:** [Inaudible].  
1005 **Dan Lake:** Obviously bro, fish and chips, isn't it?  
1006 **Callum Tulley:** Oh, he's done it? Still touched yellow first though.  
1007 **Dan Lake:** You've got to be careful. He put in a complaint and said, the officer attacked me  
1008 on camera [inaudible]. Sean was sitting on the table, he's shot over as if he was gonna hit  
1009 Sean, but still. .  
1010 **Callum Tulley:** Oh. So was it all on camera?  
1011 **Dan Lake:** Yeah, right there.  
1012 **Callum Tulley:** [Inaudible] backhanded him across the face on camera?  
1013 **Dan Lake:** No, no, picked him up on camera, carrying him into his room.

1014 **Callum Tulley:** Oh, I see.  
1015 **Dan Lake:** Threw him in his room, backhanded him in his room. But it did look like, to be fair  
1016 on Sean [inaudible], it looked like he was going to hit Sean, like the way he approached Sean  
1017 with his hands back like that.  
1018 **Male Officer 1:** [Inaudible].

1020 **Callum Tulley:** I was with **D149** the whole time.  
1021 **Dan Lake:** [Inaudible] sick?  
1022 **Callum Tulley:** He was -- yeah, he was not in a good way. He is in hospital now, isn't he?  
1023 **Dan Lake:** [Inaudible] he's a dickhead.  
1024 **Callum Tulley:** Eh?  
1025 **Dan Lake:** [Inaudible].

1039 **Male Officer 1:** [Inaudible].  
1040 **Callum Tulley:** Oh, was there another one? Oh was there four?  
1041 **Male Officer 1:** He was in the courtyard as well, apparently he was alright.  
1042 **Callum Tulley:** Oh right.  
1043 **Male Officer 1:** [Inaudible].  
1044 **Callum Tulley:** He hasn't seen it.
