

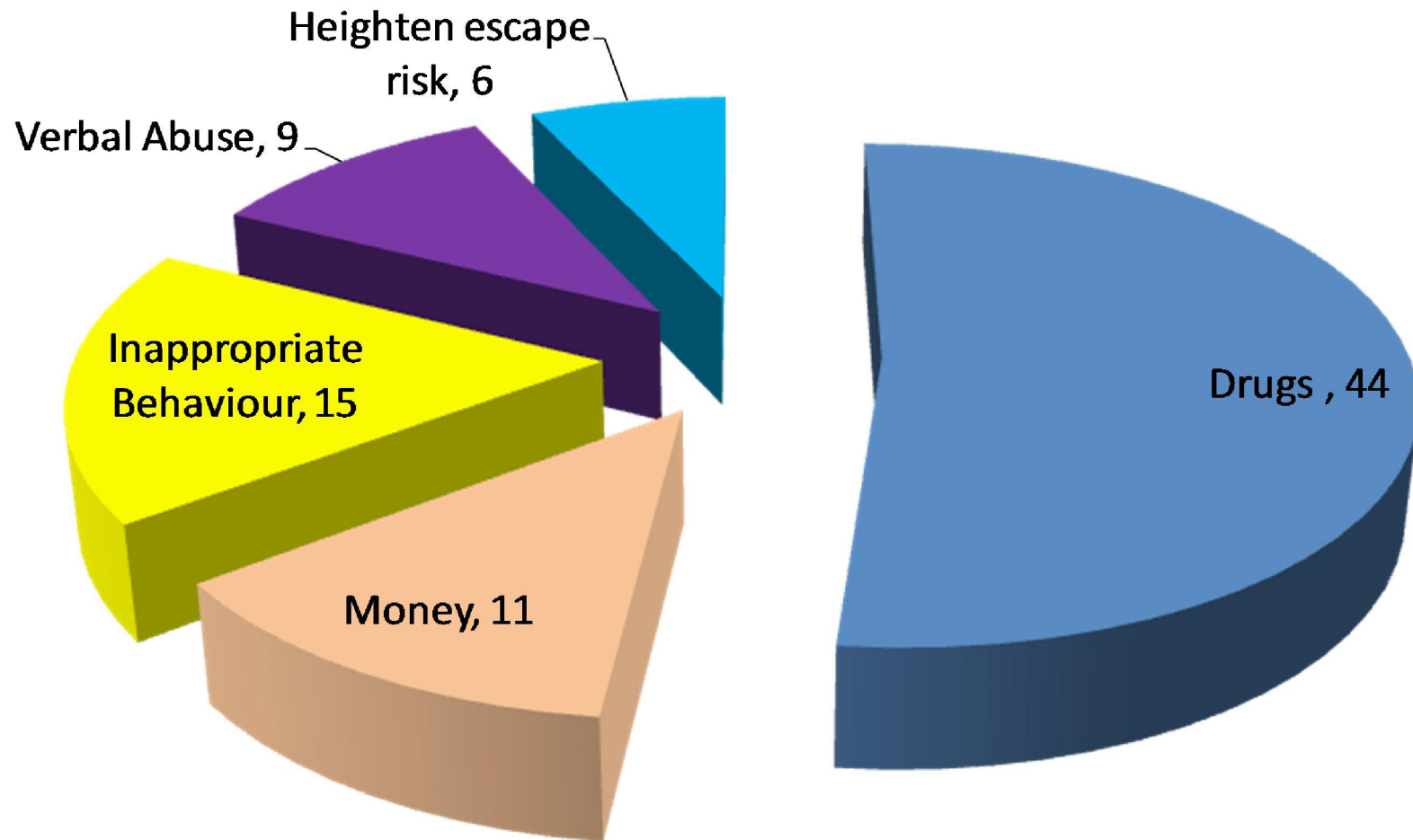

# Brook House SIRs

- On average during August Brook House had a roll count of 465 of which 33% were TSFNOs.
- During August 169 SIRs were received which is an increase of 10 on July.
- There were 131 individuals reported via SIR. Of those, 48% were TSFNO.
- 26 – 30 were the most frequently reported age group followed by 22-25. Which is a shift from August's reporting which was 31-35.
- Jamaica was the most reported nationality with Algeria being the second most reported.

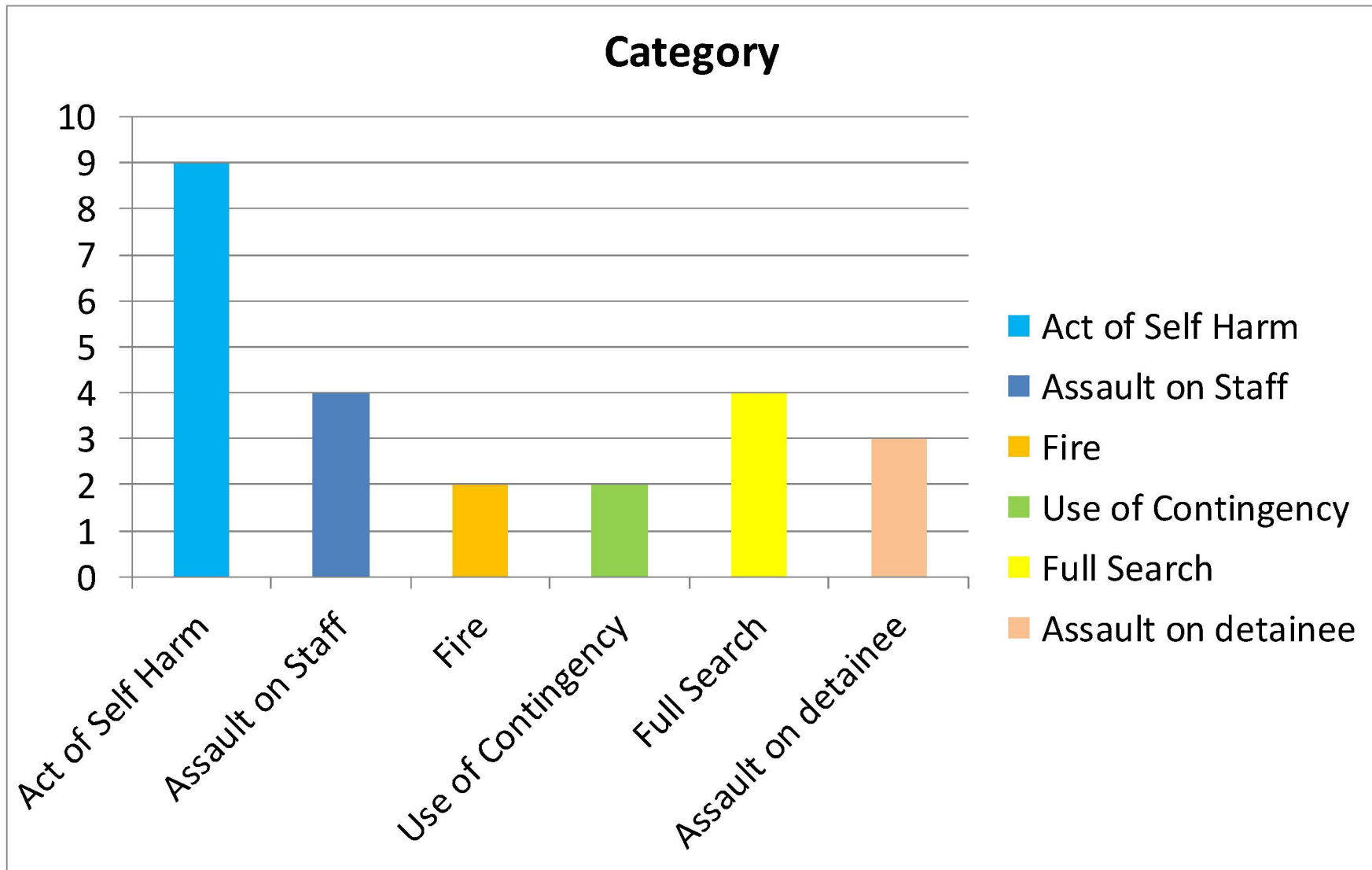

# Brook House Incident Reports

- 46 incident reports were submitted capturing a total of 60 categories during August. This is a reduction of 28 categories on July.
- 4 reports were received that related to assaults on staff, which is an increase of 1 on the previous month.
- The incident reports concerned 42 individuals. Of which 57% were TSFNOs.
- The most reported age range by far was 22-25 which is consistent with SIR reporting.
- Albania was the highest reported nationality.

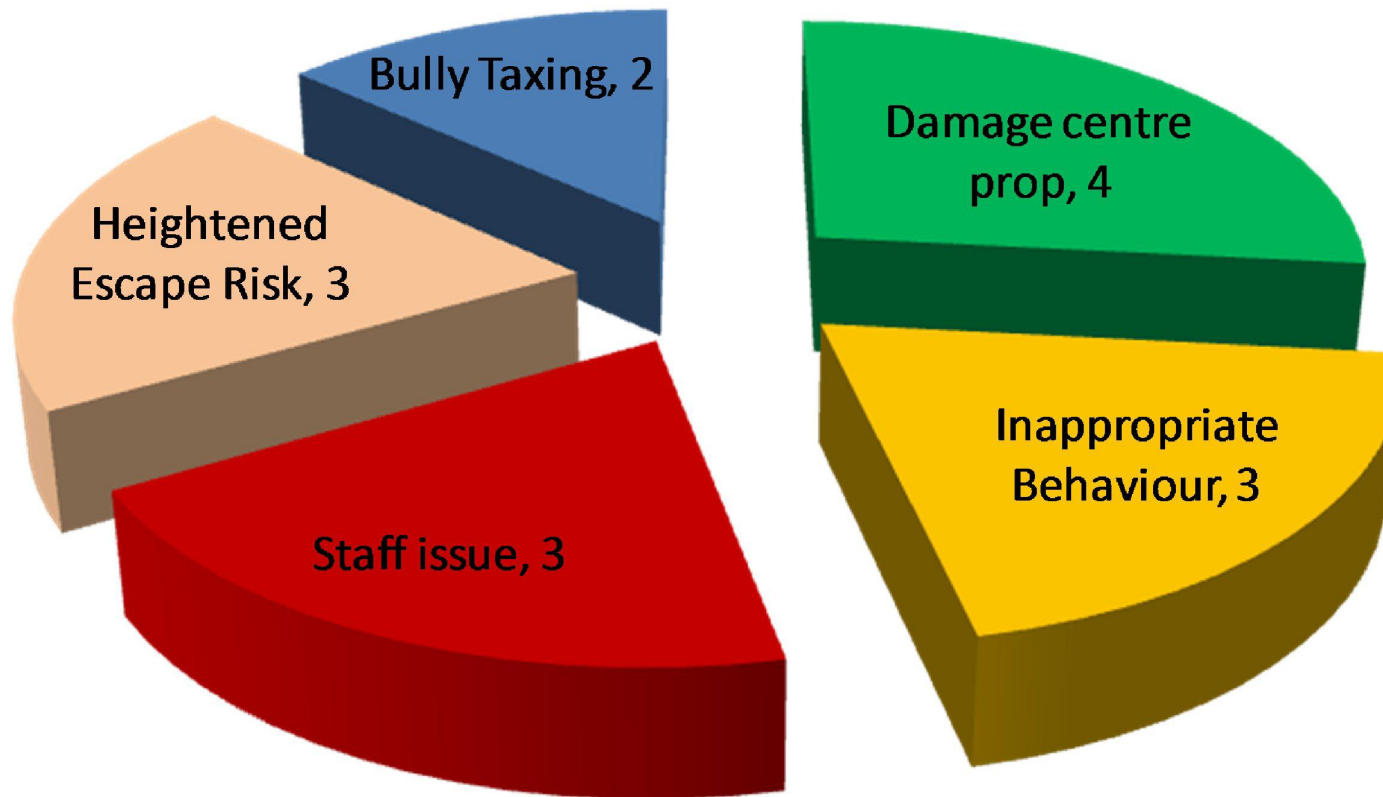

# Tinsley House SIRs

- On average during August Tinsley House had a roll count of 106 of which 16% were TSFNOs.
- During August 27 SIRs were received, this was a decline of 28 on July.
- There were 14 individuals reported via SIR. Of those, 21% were TSFNOs.
- 22-25 was the highest reported age group.

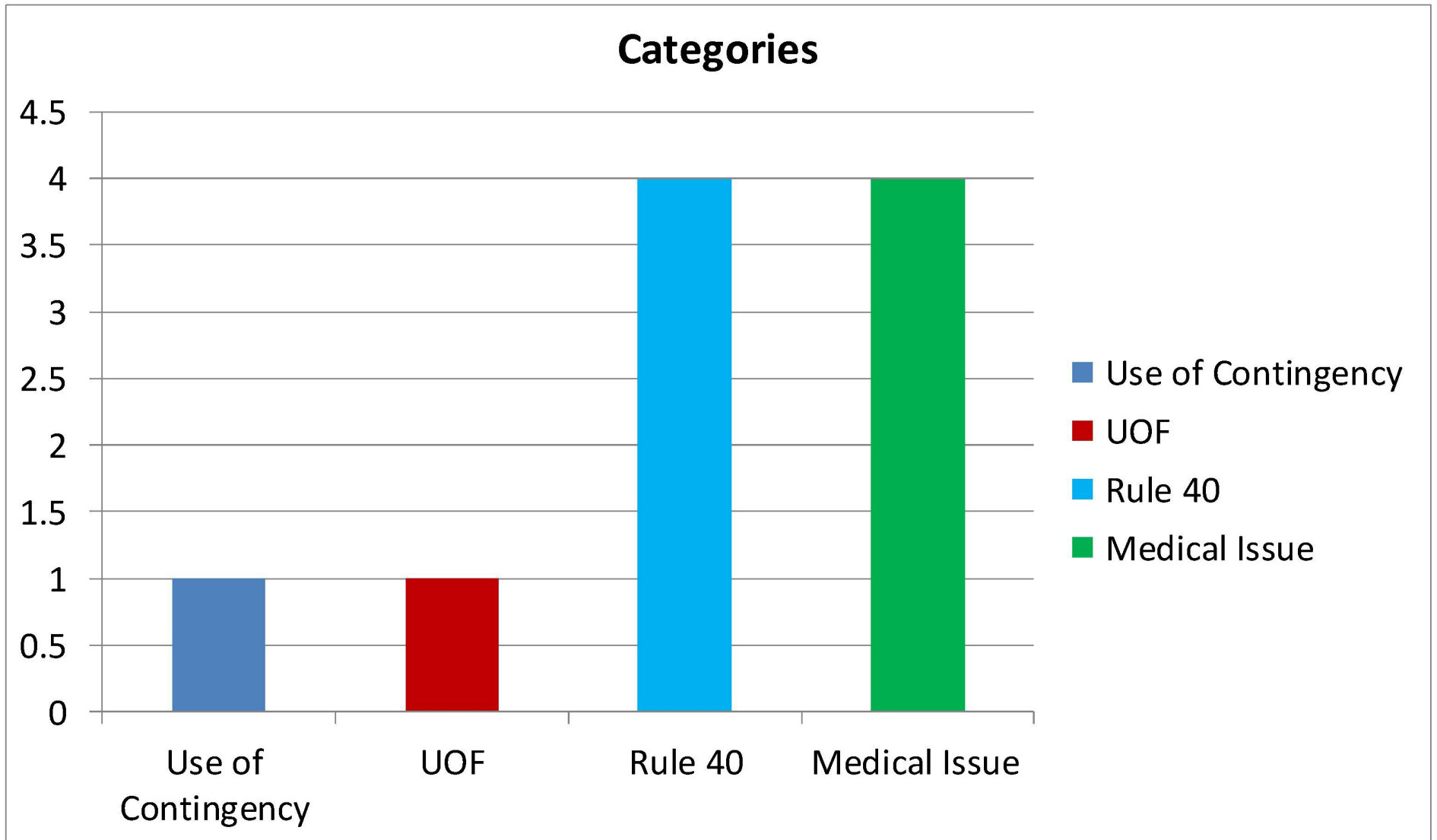


# Tinsley House IRs

- There were 7 Incident Reports submitted during August capturing a total of 10 categories.
- There were 7 individuals reported, none of who were a TSFNO.
- The most reported age ranges were 22-25 and 36-39 jointly.

D1884	Ran from Police on initial encounter.
D2177	Stated whilst in HMP if he goes to hospital he will assault staff so that he can have a cigarette
D1686	Took an interest in security during a transfer from CSU to Healthcare at previous Centre
D1718	Threatened to escape at previous Centre
D1621	Attempted to plan an escape with 4 other Polish nationals at Harmondsworth
D1024	Threats to staff during hospital visit
D813	Attempted to grab wiring at back of C wing Courtyard, from Plant pot in sterile smoking area.
D398	Weather seals from external windows found tied together in room. Denied knowledge of the article.
D2147	Followed officer around the building and stared at officers keys

D119	Whilst in a previous center D119 slipped out of a set of hand cuffs whilst on escort
D784	Attempted to escape detention in 2016
D1373	Was seen fiddling with handcuffs at the end of a company escort
D643	Believed an escape plot with outside help. Ex-military
D1020	In an out of bounds area and must have climbed an anti-dash fence.
D1519	"Acted Odd" at previous detention Centre- No further information available.
D1070	Jumped off TASCOR Van in transit
D1812	Was seen observing the escort chain, pulling at the escort chain and attempting to slide the hand cuff over his wrist during a company escort
D1120	Listed as an absconder

Name	Reason
DPA	Passed cannabis during a social visit. <b>Banned until 19/01/2018</b>
DPA	Found in possession of cannabis. Cautioned by police for possession with intent. <b>Banned until 22/09/2017</b>
DPA	Dropped a wrap of suspected class A drug during a social visit. <b>Banned until 20/11/2017</b>
DPA	Arrested at The Verne following an attempted drugs pass, previously refused entry to Brook after smelling strongly of cannabis. <b>Banned until 2017</b>
DPA	Passed package of PS through social visits- <b>Pending Home Office response</b>
DPA	Was present at the time a package of PS was passed during a social visit- <b>Pending Home Office response</b>
DPA	Passed two large wraps of cannabis and cocaine through visits- <b>Pending Home Office response</b>

# Gatwick Closed Visits and Banned Visitors

Name	Reason
DPA	Found in possession of three wraps of cannabis prior to admission to the visits hall-Pending Home Office response
DPA	Under the care of social services, concerns over welfare of visitor-Pending Home Office response

<b>D642</b>	Received drugs through the post
<b>D1300</b>	Received a pass through visits
<b>D1744</b>	Received a pouch of tobacco to a fellow detainee on E Wing that was found to contain a PS
<b>D276</b>	Admitted to receiving a pass of a controlled drug through visits.
<b>D1031</b>	Received a pass of a substantial amount of cannabis and cocaine in two large wraps through visits.
<b>D3468</b>	Visitor found in possession of three wraps of cannabis prior to visit

- There were 4 referrals during the month at Brook House.

# Breaches of Security

- There were no breaches or Key /Lock compromises recorded during August at Tinsley House.
- There were 2 breaches and 7 Key/Lock compromises recorded at Brook House.

# Trends and Hotspots at Gatwick

- *Even though drug Intel has been received there has been no significant drug finds within the centre other than of those within the visits hall.*
- *A rise in disruptive/ threatening behaviour however violence from detainees on detainee and detainees on staff has remained low though out the month.*
- *Smoking is an on-going issue at Tinsley House due to the smoking restrictions. Room searches are working with lighters being found.*
- *Doors being left unsecured at Brook House has been a consistent problem throughout the month.*



# Gatwick Objectives

- Reduce Breaches of Security at Brook House.
- Develop a clear counter acting strategy for those detainees who are repeatedly taking PS and requiring medical treatment.
- Gather intelligence on protests within Gatwick IRC and any individuals who are likely participate and incite others.
- Identify any escape risks including weaknesses in physical security and assessing all intelligence for any escape risk.
