


# Security Committee Meeting June 2017

### **Brook House SIRs**

- On average during June Brook House had a roll count of 440 of which 36% were TSFNOs.
- During June 207 SIRs were received which is a decrease of 5 from May.
- There were 137 individuals reported on all SIRs, TSFNO = 58%.
- 40 49 were the most frequently reported age group followed by 26-30.
- Jamaica was the most reported population followed by Somalia, this carries on the trend from last month.


#### **Brook House Most Commonly Reported SIRs**



## **Brook House Incident Reports**

- A total of 87 incident reports were submitted capturing a total of 9 categories during June.
- 10 Incident reports were received that related to assaults on staff.
- The incident reports concerned 80 individual. TSFNO = 40%.
- The most reported age ranges concerning incident reports were 40 – 49. This is consistent with SIRs.
- The joint three top nationalities reported were Algeria and Jamaica.


#### **Brook House Most Commonly Reported Incident Reports.**

## Tinsley House Incident Reports

- There were 3 Incident Reports submitted during June.
- 1 X Medical Issues/ Self Harm Home Office went to speak with NAME REDACTED but when they entered the room NAME REDACTED appeared to be having a seizure on the floor.
- 1 X Self Harm Detainee was in welfare when he became distressed threw a chair and ripped up some paperwork he then ran into the wall and threw himself to the floor.
- 1 X Full Search A full search was conducted on A
   Detainee in preparation for his escorted RDs at request
   of the complex removal team.

### Use Of Force

- There were 31 Uses of Force in June over both sites, used on 27 individuals.
- The most frequently restrained age groups were 40 49 followed by 26 30.
- Maintain Good Order and Discipline was the main reasons for force being used by far.

#### **Brook House Breaches**

- Visitor entrance electronic door into the main central building was found unsecure.
- A large bunch of keys was found in the staff gym stairwell. They appear to be office/notice board based keys.

## Tinsley House Breaches

There was 1 breaches recorded during June.

They were:-

 Dog Boxes in Zone C (Opposite Sports shed) were insecure. Padlocked locked around handle of door instead of bolt.

## Trends and Hotspots at Gatwick

- C Wing have had the most amount of reports submitted this month.
- There has been a large amount of reports surrounding potential drug use but not many finds.
- Incidents at height continue to be a trend within the centre with further occurrences.
- Post seemed to be the preferred method of drugs trafficking with some significant detections being made.
- 40 49 year olds are the highest reported age this month.

## Gatwick Objectives

- Develop a clear counter acting strategy for those detainees who are repeatedly taking PS and requiring medical treatment.
- Intelligence is required to identify a hierarchy where possible of the organised crime groups involved in the supply of PS, other drugs and illicit items into the centre given a number of nominal detainees have left the centre.
- The new room search forms is now in use.
- Update and implement new training package for ITC and Yearly Staff Refreshers.
