- There are new wing observation books on each wing. Staff to write in them as they
  can be a valuable tool for intelligence. These books are for general observations of
  the wing, anything that is SIR reportable still needs to go on an SIR and not in the
  observation books.
- Please note that staff have the right to search detainees at their discretion (DC rule
   7) especially if a detainee is seen under the influence
- . Can wing staff ensure rubbish is placed in bins immediately, not left by wing door
- In the event that a visitor has been refused access to the Centre, please can you complete an SIR including the details and circumstances as to why they visit was refused
