CONTENT OF REPORT

ON THE 19TH OF MAY 2017 MR D2144 HANDED ME PIECE OF PAPER STATING THAT HE LOVES ME AND ASKING ME TO GIVE HIM MY NUMBER. I TOLD HIM I WILL NOT GIVE HIM MY NUMBER AS WELL AS TOLD HIM THAT HIS BEHAVIOUR IS TOTALLY UNACCEPTABLE. MR D2144 TEND TO FOLLOW ME THAT DAY ON A WING. WHENEVER I WAS TELLING HIM TO STOP IT HE WAS TELLING ME HE WILL EITHER JUMP ON THE NETTING OR CUT HIMSELF. (REGARDING CUTTING DCM JAMES B. WAS INFORMED FEW DAYS AGO WHEN MR D2144 STATED IT FOR THE FIRST TIME, HEALTHCARE WAS INFORMED AS WELL) WHENEVER CHALLENGED ABOUT CUTTING HE IS SAYING HE IS JOKING. TODAY, 20TH OF MAY 2017 I OPENED COURTYARD (A WING) AS THERE WAS STAFF SHORTAGE, MR D2144 AS SOON AS SAW ME ON THE COURTYARD CAME CLOSER TO ME, HIS COMMENTS TOWARDS ME WERE VERY INAPPROPRIATE, HE WAS SAYING →

"GIVE ME YOUR NUMBER", "YOU ARE MY WIFE". THEN HE STARTED TO TALK TO OTHER DETAINEES IN HIS LANGUAGE ONE OF THE DETAINEES CAME UP TO ME AND SAID THAT MR D2144 WAS TALKING VERY RUDE ABOUT ME, AND SAID "JUST BE CAREFULL AS HE IS CRAZY ABOUT YOU AND HE WAS SAYING A LOT OF RUDE THINGS HE WOULD DO TO YOU"
