Incident Statement By (print name): Detainee Custody Manager Nick London

Please describe the Incident details in full, confirming details of place of incident, time, date, names of all persons involved, witnesses, injuries sustained, first aid or healthcare provided, and details of which managers were informed of incident.

On the evening of Wednesday 5<sup>th</sup> 2017 at approximately 2100hrs detainee **D728** was refusing to go into his room at lock up. I DCM Nick London was called by control as the oncoming duty Oscar 1. On arriving at Arun Wing second floor **D728** had jumped onto the netting and had a ligature around his neck. After talking with **D728** he jumped back off the netting and escorted to the Care and separation unit. **D728** was placed rule 40 to maintain good order within the centre. **D728** was placed on a constant supervision as he had made threats to his own life. When talking with **D728** it transpired that this was all triggered as he has not received his medication for 3 days now. This has made **D728** extremely low and makes him think of doing bad things to himself. This Concludes my report.
