

126 **Radio:** Attention all stations. Stand down medical response. I repeat stand down medical
127 response.

128 **Sue (Female Medical Staff):** Heart rate's 102, SAPS are 96, lovely. Okay, 96 and 102.

129 **Male Medical Staff 1:** What's his BM?

130 **Sue (Female Medical Staff):** 5.2.

131 **Female Medical Staff 1:** 5.2 [inaudible].

132 **Sue (Female Medical Staff):** Okay, there's [inaudible] have a look at those pupils. We'll soon
133 know, won't we? What we're dealing with.

134 **Callum Tulley:** What's that?

135 **Sue (Female Medical Staff):** We're now at 96. What's his name, Pat[?]?

136 **Male Medical Staff 1:** I think it's [D3902] or something.

137 **Sue (Female Medical Staff):** [Inaudible].

138 **Male Medical Staff 1:** I call him [D3902] [inaudible].

139 **Gus (Male Medical Staff):** How did you get [inaudible]?

140 **Sue (Female Medical Staff):** I was just [inaudible]. Sir, look at me for a minute.

141 **Male Medical Staff 1:** [D3902].

142 **Sue (Female Medical Staff):** [D3902]? That's it.

143 **Sue (Female Medical Staff):** That's it.

144 **Male Medical Staff 1:** All right, yeah –

145 **Sue (Female Medical Staff):** Turn over for a minute.

146 **Gus (Male Medical Staff):** Just hang on for a minute for a minute, yeah?

147 **Male Medical Staff 1:** We're all ready for him.

148 **Callum Tulley:** Which way? This way?. That's it, that's it.

149 **Sue (Female Medical Staff):** That's it. Let's open your eyes. Oh, like saucers, that's what we
150 like. You've had a good old time, haven't you? Eh? Was that fun?

151 **Gus (Male Medical Staff):** Okay?

152 **Sue (Female Medical Staff):** Yeah, we're there. Just stay there for me. You just enjoy the
153 good time. It doesn't look very good, does it?

154 **Callum Tulley:** It doesn't look like fun to me.

155 **Sue (Female Medical Staff):** No. You stay there, that's it. 105-67, his pulse is coming down,
156 it's now 87.

157 **Gus (Male Medical Staff):** Well, that's good, isn't it?

158 **Sue (Female Medical Staff):** Yeah.

159 **Callum Tulley:** 87's all right, isn't it?

160 **Sue (Female Medical Staff):** Yeah, it's good.

161 **Callum Tulley:** See – see if we can take him down to E Wing, then?

162 **Sue (Female Medical Staff):** It will be an E Wing job, yeah.

163 **Callum Tulley:** Cool.

164 **Chris Brown:** Shall we get his down to E-Wing?

165 **Callum Tulley:** Do you think we could get –

166 **Sue (Female Medical Staff):** E Wing, yes, please.

167 **Callum Tulley:** Do you think he might be able to walk, or do you want to just put him in a
168 chair?

169 **Male Medical Staff 1:** Get a chair would be cool.

170 **Chris Brown:** [Inaudible] get back up.

171 **Gus (Male Medical Staff):** [D3902] can you walk?

172 **Sue (Female Medical Staff):** Can you stand up for me?
173 **Gus (Male Medical Staff):** [D3902] do you want to stand up? We'll take you down to E Wing
174 just to chill a bit, just keep an eye on you, yeah? Come on, buddy, hold my hand. Up you get.
175 **Callum Tulley:** That's it. Just – yeah, there we go.
176 **Gus (Male Medical Staff):** All right, we need to walk to E Wing now.
177 **Sue (Female Medical Staff):** Yeah, let's not fall over with him, that's it.
178 **Chris Brown:** Okay.
179 **Sue (Female Medical Staff):** One of those pillows has got blood on it, so just be aware. Just
180 throw it out the way.
181 **Callum Tulley:** Do you think you can walk down to E Wing, or do – do – would you rather us
182 take you in a chair?
183 **Gus (Male Medical Staff):** Do you want a chair, or do you want to walk? Here, put your shoes
184 on.
185 **Chris Brown:** Shall we get the chair, or we can put him straight in the lift?
186 **Callum Tulley:** Yeah, okay. Yeah, no worries.
187 **Gus (Male Medical Staff):** Get your shoes on. Well, there you are.
188 **Sue (Female Medical Staff):** You're going for a trip down to E Wing.
189 **Gus (Male Medical Staff):** [Inaudible].
190 **Callum Tulley:** Well, Dean wants him in a chair, doesn't he?
191 **Sue (Female Medical Staff):** Yeah.
192 **Gus (Male Medical Staff):** Wait there, just wait.
193 **Chris Brown:** [Inaudible], okay?
194 **Sue (Female Medical Staff):** Yeah. Yeah, yeah.
195 **Gus (Male Medical Staff):** I think [inaudible].
196 **Sue (Female Medical Staff):** Just a sec, okay.
197 **Gus (Male Medical Staff):** Have you got – have you got a chair here?
198 **Sue (Female Medical Staff):** It's hot in here.
199 **Callum Tulley:** It is hot, isn't it? Who found him? Did you find him?
200 **Chris Brown:** No, one of the detainees told Gus –
201 **Callum Tulley:** Oh, right.
202 **Chris Brown:** – that he was in here. He'd been in here for about five minutes before Gus even
203 found him.
204 **Callum Tulley:** Oh.
205 **Sue (Female Medical Staff):** Yeah, well, I don't think we'll be having any of that, guys. I
206 think your stash is gone, mate. It's gone.
207 **Gus (Male Medical Staff):** Well, buddy. He's still looking for his spliff, I think.
208 **Sue (Female Medical Staff):** He's still looking for a spliff [laughs].
209 **Chris Brown:** I'm just going to get the chair. Is he still wobbly, or...?
210 **Callum Tulley:** He is a bit wobbly.
211 **Sue (Female Medical Staff):** I think you enjoyed your little stash that's going on.
212 [D3902] **(Detainee):** What? I don't know [inaudible].
213 **Male Medical Staff 1:** Can you walk?
214 [D3902] **(Detainee):** Where am I?
215 **Sue (Female Medical Staff):** Where has it gone? [laughs.]
216 [D3902] **(Detainee):** Who?
217 **Male Medical Staff 1:** You.

310 **Male Medical Staff 1:** He's not smoking anything for a little while. Come on, mate, let's go.
311 **Callum Tulley:** Sorry, did you see something, Sue?
312 **Sue (Female Medical Staff):** Yeah. Yeah, yeah, I've seen something. I heard him saying he's
313 got something tucked in his pants.
314 **Callum Tulley:** Oh, right. Okay, we need to search him.
315 **Sue (Female Medical Staff):** Yeah?
316 **Male Medical Staff 1:** Come on, mate.
317 **Callum Tulley:** And then tell Dean, because I can't authorise the full search.
318 **Sue (Female Medical Staff):** Yeah.
319 **Male Manager 1:** Are you all right, mate? What are you doing?
320 **Male Manager 1:** What on earth are you doing?
321 **Unknown Speaker:** Yeah, he walk in. Yeah, he was [inaudible].
322 **Sue (Female Medical Staff):** Sit yourself down before you fall down. [Another detainee on
323 the wing appears, walking unstably and moving erratically]
324 **Male Manager 1:** Sit down, my friend. Come on.
325 **Male Manager 1:** Sit down.
326 **Male Manager 1:** Sit on that chair.
327 **Male Manager 1:** He's far gone.
328 **Sue (Female Medical Staff):** Dear God, another one. [The manager assists the detainee to
329 lie flat on his back on the floor.]
330 **Male Manager 1:** Come on, mate.
331 **Male Manager 1:** [Inaudible] sit down.
332 **Sue (Female Medical Staff):** I need to to vax[?], I need to vax. [Inaudible].
333 **Callum Tulley:** Shall I put him in a recovery position?
334 **Sue (Female Medical Staff):** Yeah.
335 **Male Manager 1:** [Inaudible] There's another medical response to Alpha on the top floor. Can
336 you ask healthcare to return the [inaudible].
337 **Radio:** Is that the same room?
338 **Male Manager 1:** Yeah, we're outside the same room, yeah.
339 **Radio:** Stations, please call response to Alpha 2-20. [Inaudible] call response to Alpha 2.20.
340 **Male Officer 2:** [Inaudible], we need someone out here.
341 **Male Manager 1:** Yeah, I've called the response, so there's people coming.
342 **Sue (Female Medical Staff):** Now I've got no kit. [Inaudible] behind his knee [inaudible].
343 One of these days, somebody's going to get carried out in a body bag.
344 **Male Manager 1:** Smoking, no good. Look at him. That's what you were doing. [Manager
345 addressing **D3902**, pointing to unconscious detainee on the floor.]
346 **D3902 (Detainee):** [Inaudible]
347 **Male Manager 1:** Yeah, that is what you were doing in there.
348 **Sue (Female Medical Staff):** If you want to die, best way to do it.
349 **Gus (Male Medical Staff):** **D612** are you all right?
350 **Sue (Female Medical Staff):** Hi? Stay there for me.
351 **Male Manager 1:** Just lay down, mate.
352 **Sue (Female Medical Staff):** Yeah, stay down.
353 **Male Manager 1:** Stay where you are.
354 **Sue (Female Medical Staff):** Stay down, pop your head down.

401 [D612] (Detainee): [D612]
402 Male Medical Staff 1: [D612] [D612], all right. Yeah?
403 Male Medical Staff 1: Have you had something to smoke, or eat or drink of anything?
404 Smoking, yeah? Do you know what you're smoking?
405 Sean Sayers: Is this another one that you want – do you want him down there as well?
406 Sue (Female Medical Staff): [Inaudible], yeah.
407 Callum Tulley: So, shall we help him? Shall we help him up? Do you reckon you can get up
408 for us? Do you reckon you can get up for us?
409 Sue (Female Medical Staff): You'll have to turn back for the next one. [Laughs]
410 Sean Sayers: He can't get up.
411 Radio: Yeah, [inaudible] Wing. Over.
412 Sue (Female Medical Staff): Oh, I'm sorry.
413 Male Medical Staff 2: That's all right.
414 Sue (Female Medical Staff): Do you want me to keep hold of your bag?.
415 Sean Sayers: I'm going to take you somewhere where you're going to sleep, yeah?
416 Sean Sayers: All right, then.
417 Sean Sayers: Bro? All right? Sit up. Sit up for me. Come on, sit up.
418 Callum Tulley: He'll sit you up, mate.
419 Sean Sayers: Sit up.
420 Sue (Female Medical Staff): [Inaudible] leaving.
421 Callum Tulley: That's it, that's it, or sit down.
422 Sean Sayers: Grab a hold of his arm. [Sean Sayers and another officer attempt to lift the man
423 by his arms].
424 Sean Sayers: Do you need a chair?
425 Callum Tulley: Maybe he needs a chair.
426 [D612] (Detainee): [Inaudible]
427 Sean Sayers: We need a chair.
428 Callum Tulley: Where's the chair? Is it still out there?
429 Sue (Female Medical Staff): It's still outside.
430 Sue (Female Medical Staff): Is it still outside?
431 [D612] (Detainee): I wanted to die, I wanted to die, I wanted to die. [D612] repeats this
432 phrase while jerking his body forwards erratically]
433 Callum Tulley: Just take a seat, mate.
434 [D612] (Detainee): I wanted to die, I wanted to die, I wanted to die.
435 Callum Tulley: There we go.
436 Sean Sayers: Okay, take a seat.
437 Callum Tulley: There we go, there we go. Good man.
438 [D612] (Detainee): I wanted to die, I wanted to die, I wanted to die, I wanted to die, I
439 wanted to die, I wanted to die. I wanted to die. I would have been lucky. I would have been
