Content of Report

The following occurred at Brook House Immigration Removal Centre, Perimeter Road South, Gatwick Airport, RH6 OPQ.

My name is Detainee Custody Officer (DCO) Callum Michael Tulley and I have been working live at Brook House IRC as an Activities DCO since the 15th of June 2015. At approximately 1355 I was stood inside the library by the door when I felt a tugging on my key chain. I turned around to see **D149** fiddling with my keys. I believe he was attempting to take them. I then went to the security office and informed Senior Manager Kaz and DCO Jason Murphy. This concludes my report.

I have not entered the details in the unit / area observation book.

I have/have not informed my line manager of the content of this report.

CCTV viewed and shows D149 going for the keys of R/O. Shown as escape risk prior to this incident when he previously attempted to get the keys and radio of another officer at another centre.

Placed on Rule 40. GBH. Boasts he has killed someone. Drugs user. Verbally abusive to female officers. Shows racist behaviour.

INTELLIGENCE ASSESSMENT

Intelligence suggests that the detainee has attempted to get hold of the officer's keys in a possible attempt to escape from Brook House.
