home office are to help him look at his paper work and his case and he will see his solicitor tomorrow, he is booked in with the doctor for anti depressants states his sleep pattern is not very good, wants to see mental health nurse that did reception is the mental health nurse and has put in the note that they will see him on monday, he is very frustrated but states he will not hurt himself today but in the future if his case is not sorted he does not know what will happen, himself, CM and governor have agreed he would be better on the wing as he can get out and do things, he will still remain on high observations by officers as he has come off constant watch.

Came from Somalia - states that he was Sensitive/irrelevant abused in a camp in Mogadishu. only recently disclosed, only mum and sister know from his family as he is confident they will keep confidentiality. trained mechanic - but got into trouble doing Sensitive/irrelevant states he went to police and admitted everything but didnt give names of his friends - wanted to 'sort' himself out.

has been in care previously. Nan and brother have died since he has been detained.

apparently previously told he has ADHD and Dyslexia - never been on medication

Attempted ligature recently. states he was due to start medication (awaiting notes merger). states he is trying to 'give this place a go' but ongoing thoughts and plans (undisclosed) for suicide due to distress of situation. 'I'll leave here in a body bag otherwise'.

feels low, although very agitated, doesnt want to mix, doesnt want to apply for bail as wants to have right to remain and work. doesnt want to be out living on 'handouts'.
